REQUEST FOR PROPOSAL: INVITATION TO SUBMIT A PROPOSAL THAT WILL PROVIDE ESKOM WITH LEGAL SERVICES RELATED TO PROVISION AND CONCLUSION OF GRANT FUNDING FROM USTDA AND SUPPLY CONTRACT BEING FUNDED RELATING TO TECHNICAL ASSISTANCE RELATED TO THE USE OF INNOVATIVE TECHNOLOGIES AND APPROACHES TO IMPROVE SOUTH AFRICA'S TRANSMISSION GRID, INCLUDING ARTIFICIAL INTELLIGENCE TOOLS FOR SYSTEM STABILITY, ADVANCED GRID CONTROL, ENERGY STORAGE SYSTEMS, AND MARKET MODELLING RELATED TO THE USE OF INNOVATIVE TECHNOLOGIES LOCATED IN SOUTH AFRICA. .

### 2. OBJECTIVE

In its endeavours to meeting its climate targets The Government of South African (GoSA) strives for a significant shift in the country's energy mix towards renewable energy with a focus on building sustainable "green" transmission infrastructure. The GoSA has called for more research support as South Africa embarks on significant energy sector reforms. This feasibility study for Eskom Holdings SOC, Ltd. will support the development of modern "green" transmission and distribution technologies in Eskom's 10-year grid expansion plan that could make its electric grid more sustainable, reliable, robust, and efficient in South Africa. The

primary objective of the Study is to assess the technical, economic, financial, and other key elements of the Project and provide the Grantee with necessary feasibility analysis, data and recommendations required for financing and implementation the Project.

Eskom wishes to engage POWER Engineers, a United States firm organized under the laws of the State of Idaho to deliver technical assistance related to the use of innovative technologies and approaches to improve South Africa's transmission grid, including artificial intelligence tools for system stability, advanced grid control, energy storage systems, and market modelling related to the use of innovative technologies located in South Africa. The intention is that this advice will be paid for through grant funding provided by the United States Trade and Development Agency ("USTDA"). As the agreement is governed in terms of United States Law, and involves the procurement of services, Eskom requires external legal advice in concluding the contract.

The respondent must have a clear and documented domestic and international presence or affiliation and provide proof thereof when submitting the quotations as legal services in both domestic and international laws (including US Law) is required.

The Law firm must price separately in ZAR for domestic and USD for international legal services.

This is an open invitation to tender and the objective of the RFP is to solicit offers from credible Legal institution(s), Firms or companies to provide Legal Advisory Services ("Legal Advisor") for:

- a) To provide support with respect to
  - i. the conclusion of a grant funding agreement with the USTDA; and
  - ii. the conclusion of a supply contract with the contracted supplier for which the grant funding has been secured.
- b) The Legal Advisor will be required to advise on the legal aspects of the agreement including but not limited to
  - i. Ability of Eskom to enter into the agreement in the context of the requirements of the Public Finance Management Act ("PFMA");
  - ii. The US obligations arising from the agreement including Office of Foreign Assets Control ("OFAC") requirements and United States money laundering requirements; and

- iii. Legal considerations given that the agreement is governed by United States and New York law.
- iv. And all ancillary services

## **Skills Required**

- A minimum 5 years' experience dealing with the PFMA
- A minimum of 10 years' experience dealing with United States law, New York law OFAC, and US money laundering requirements.

### 3. ELIGIBLE TENDERERS

Tenderers must be registered legal services institution, offering legal services relating to development finance including grant funding, corporate and investment banking, advisory Treasury related international law (including US Law), South African law, and financial law, capital raising or any other treasury related services.

Tenderers are deemed **ineligible** to submit a proposal if they have the nationality of a country on any international sanctions list. A Tenderer shall be deemed to have the nationality of a country if it has the status of a national or is constituted, incorporated, or registered and operates in conformity with the provisions of the laws of that country.

### 4. CONFLICT OF INTEREST

A Tenderer shall not have a conflict of interest. All Tenderers found to have a conflict of interest shall be disqualified. Tenderers must submit a form, see Annexure B, stating that none of its personnel have any involvement or interest in Eskom and any of its subsidiaries and likewise no Eskom personnel have any involvement or interest in the Tenderer's business with the response to this document or influence the decisions of Eskom during the bidding process.

A Tenderer may also be considered to have a conflict of interest with one or more parties in the RFP process, if they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the proposal of another Tenderer. Alternatively, the bidder must disclose **ALL** such information in its response submission containing sufficient disclosure regarding any interests that may result in an actual or potential conflict of interest. Where any potential or actual conflict of interest arises after the submission of the proposal or during the term of the potential mandate, the Tenderer shall be obliged to immediately notify Eskom thereof in writing. Note that Eskom reserves the right to disqualify a Tenderer or terminate the services as service provider if there is, in the opinion of Eskom, any actual or perceived conflict of interest.

#### 5. COSTS OF TENDERING

The Tenderer shall bear all costs related to the preparation and submission of their RFP responses. Eskom shall in no way be responsible or liable for any of these costs regardless of the conduct or outcome of the procurement process.

#### 6. SCOPE OF REQUIREMENT

Eskom is inviting credible Legal institution(s) to provide Eskom with the following scope of work customary to a development finance (with experience in grant funding advisory):

- Negotiating and reviewing of grant financial documentation
- The conclusion of grant funding agreement.
- To provide support with respect to advise on the legal aspects of the agreement including but not limited to the ability of Eskom to enter into the agreement in the context of the requirements of the Public Finance Management Act ("PFMA");
   The US obligations arising from the agreement including Office of Foreign Assets Control ("OFAC") requirements and United States money laundering requirements; and
- Advising on legal considerations given that the agreement is governed by United States and New York law.
- · Advise on all ancillary services.
- Assistance in preparation and fulfilment of the required Conditions Precedents to disbursement of the grant funding, and the conclusion of supply contract with the contracted supplier for which the grant funding will be secured.

## 7. MANDATORY PROPOSAL RESPONSES

The RFP response should cover all the criteria stipulated in the attached Annexure A and must be a maximum of 20 pages, Arial font size 11. The Tenderer must submit the following:

- one (1) original, and four (4) copies of the original response,
- signed integrity declaration form,
- original or certified copy of B-BBEE verification certificate,

Failure to submit the original response, associated copies and integrity declaration form will disqualify your submission. Failure to submit B-BBEE verification certificates will not result in disqualification but will impact the scoring.

#### 8. EVALUATION CRITERIA

Responses to cover the criteria in Annexure A will be scored out of 90. B-BBEE status will be scored out of 10 in accordance with PPPFA. Tenderers will be ranked by applying the preferential point scoring based on the 90/10 principle.

Bidders are expected to demonstrate and illustrate:

- 1. In depth expertise and specialised knowledge of international and domestic Banking and Finance Law, specific to developmental finance including grant financing. This is to be illustrated by providing details and specifications of where at least one of the members of the intended team has been the project lead and had a clear and documented domestic and international presence or affiliation and provide proof thereof when submitting the quotations as legal services in both domestic and international laws (including US Law) is required on at least three projects or matters dealing with grant funding loans, in excess of US10 million per project, providing detailed information on the extent and depth of the level of services provided.
- 2. The Law firm must price separately in ZAR for domestic and USD for international legal services. This is an open invitation to tender and the objective of the RFP is to solicit offers from credible Legal institution(s), Firms or companies to provide Legal Advisory Services ("Legal Advisor") for: to provide support with respect to i. the conclusion of a grant funding agreement with the USTDA; and ii. the conclusion of a supply contract with the contracted supplier for which the grant funding has been secured.
- 3. The Legal Advisor will be required to advise on the legal aspects of the agreement including but not limited to i. Ability of Eskom to enter into the agreement in the context of the requirements of the Public Finance Management Act ("PFMA"); ii. The US obligations arising from the agreement including Office of Foreign Assets Control ("OFAC")

requirements and United States money laundering requirements; and iii. Legal

considerations given that the agreement is governed by United States and New York law.

4. In depth knowledge of US law by one of the team members and indepth knowledge of

South African law by one of the team members.

Failure to provide this information will lead to disqualification and the tenderer will not be

evaluated further without any clarification. The minimum percentage to be achieved to proceed

to the next stage of evaluation is 70%.
