1. PURPOSE

The purpose of the contract is to acquire the professional services of a consultant, with extensive experience and technical competency to conduct air space assessment, determine the remaining useful lifespan of operational landfills, and calculation of landfill provision at the City of Tshwane landfill sites.

2. BACKGROUND

The City of Tshwane has a total of ten landfill sites, of which six are closed and four are operational to provide waste disposal services to residents and businesses within its jurisdiction. In order to ensure sustainable landfill operations and effective long-term planning for waste disposal infrastructure, the City is required to regularly assess the remaining landfill airspace capacity and financial provisioning requirements for landfill closure and rehabilitation.

Accurate determination of the remaining airspace capacity of landfill sites is essential for planning future waste disposal requirements, determining the lifespan of landfill facilities, and supporting the City's strategic waste management planning. In addition, municipalities are required to make financial provisions for the rehabilitation, closure, and post-closure management of landfill sites in accordance with applicable environmental regulations.

The City therefore intends to appoint a competent service provider to conduct airspace assessment and landfill provisioning for its landfill sites.

The required services are guided by the mandatory requirement to ensure that the City's landfill sites comply with the Accounting Standards Board Guideline on Accounting for Landfill Sites (ASB, 2019), as well as other relevant regulatory framework.

3. DESCRIPTION OF SERVICES REQUIRED

3.1 Airspace Assessment

The consultant will be required to conduct a waste volume survey to determine the landfill airspace and the remaining useful lifespan of the remaining permitted four operational landfill sites. The assessment must also include measurements of the height at which the active waste beam is being operated to establish if the height complies with the maximum permitted height restriction for the landfill sites under survey.

3.2 Landfill Provision Calculations

The service provider will be required to calculate and prepare the landfill provision quantum report for both operational and closed landfill site in accordance with the guidelines provided by the Accounting Standards Board Guideline on Accounting for Landfill Sites (ASB, 2019). The report must include the calculations for the present and future value projections for the assets under assessment.

4. PROJECT SCOPE

The consultant will be required to perform, amongst others, the following duties:

4.1. Airspace Assessment

- a. Compile the waste volume survey and project the remaining useful lifespan for each site
- b. Present data on the type of waste disposed per site and the footprint of the area turned versus the remaining undeveloped cells per landfill site
- c. Present the airspace assessment for each site under study and indicate the expected year of decommissioning for each site
- d. Present the topographical surveys as well as the electronic models and drawings illustrating the design layout of the permitted future shape of the landfill site
- e. Reports on the airspace assessment must be submitted to the City within 30 days and it will be submitted to GDARD from the date on which the consultant finalized the assessment

4.2. Landfill Provision

- a. Compile a landfill provisioning report with calculations for the City's ten (10) landfill sites
- b. Report must contain provisioning for present and future value liabilities for rehabilitation, maintenance and monitoring of the sites under survey
- c. Landfill provisioning report to be prepared for the financial year 2025/26.
- d. Reports on the landfill provision quantum will be reviewed by AGSA during 2025/26 audit cycle.

5. DELIVERABLES

The appointed service provider will be required to submit the following deliverables:

- a) Topographical survey data and mapping of landfill sites.
- b) Landfill airspace assessment report indicating remaining capacity.
- c) Waste disposal rate analysis report.
- d) Landfill lifespan projections based on current waste disposal trends.

- e) Financial provisioning report for landfill closure, rehabilitation, and post-closure care.
- f) Technical recommendations for landfill capacity management and future waste disposal planning.

6. VALIDITY PERIOD

The validity period for the quotation after closure is 90 days.

7. STAGES OF EVALUATION

This bid will be evaluated in three evaluation stages namely:

- **Stage 1:** Administrative compliance
- **Stage 2:** Mandatory
- **Stage 3:** Preference point system

- Minimum 3 years' experience in landfill engineering, landfill capacity assessments, or solid waste management projects.
- Proven experience in managing landfill airspace surveys, volumetric calculations, and landfill financial provisioning studies.
- Experience preparing technical reports for municipalities or regulatory authorities.

2. Survey / GIS Specialist

- **Qualifications:**
 - Bachelor's degree in surveying, Geomatics, Civil Engineering, or related field.
 - Registration with the South African Geomatics Institute (SAGI) or recognized professional body preferred. **Attach proof of registration certificate**
- **Experience:**
 - Minimum 3 years' experience conducting topographical surveys, drone surveys, and GIS-based volumetric modelling for landfills or earthworks.
 - Experience with GPS, total station, or drone survey technologies and digital terrain modelling (DTM).

3. Environmental / Waste Management Specialist

 - Bachelor's or higher degree in Environmental Science/ Environmental Management, or Waste Management.
 - Registration with relevant professional bodies (e.g., South African Council for Natural Scientific Professions (SACNASP)) preferred. **Attach proof of registration certificate**

 - Minimum 3 years' experience in landfill environmental management, including landfill closure, rehabilitation, and monitoring.
 - Knowledge of Waste Management License conditions, airspace calculations, and financial provisioning regulations.

4. Financial Provisioning / Cost Specialist

 - Bachelor's degree in accounting/ Finance, Civil/Environmental Engineering with project cost experience, or Quantity Surveying.

 - Minimum 3 years' experience in calculating landfill closure, rehabilitation, and post-closure financial provisioning.
 - Experience in preparing municipal financial provision reports in compliance with the relevant regulatory framework.
