Johannesburg City Parks and Zoo is the custodian of green spaces in and around the city of Johannesburg. Our portfolio includes but not limited to, the beautification and maintenance of the city's open spaces. In order to reflect that, the space we operate in needs to go through a major revamp.

We would like to source a service provider that can create a living wall and wall branding for our entrance areas at 40 De Korte Street, Braamfontein. The living walls need to be as self-maintained as possible, we are open to suggestions as to best practice regarding the creation and maintenance of such walls – these suggestions should be included in your quotation as a proposal. In addition to that we require plants to be installed in the suspended ceilings in the reception area.

*(delete whichever is not applicable for this tender).*

- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

## CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
