Please Note:

1. Late bids, telegraphic bids or bids send by fax will not be considered.
2. The lowest or any bid will not necessarily be accepted and the Municipality reserves the right to accept where applicable a portion of any bid.
3. Section 217 of the Constitution of the Republic of South Africa requires an organ of state to contract for goods and services in accordance with a system which is fair, equitable, transparent, competitive and cost effective. This Supply Chain Management Policy of the Municipality

has been drawn up to give effect to this principles and the Preferential Procurement Regulations, and furthermore to comply with the provisions of the Local Government: Municipal Finance Management Act, 2003 (Act No 56 of 2003 as amended in 2017) and regulations promulgated in terms thereof. Points will be allocated on a 80/20 basis, whereby 80 points will be allocated for price and 20 points will be allocated according to B-BBEE Status level Verification Certificate.

4. No reasons will be given for the non-acceptance of tenders nor will the Municipality enter into correspondence in connection therewith.
5. Bids that are invalid, non-responsive in terms of Clause 7.2.14 of the Supply Chain Management Policy will be disqualified at the opening of the bids.
6. Tenderers should have specific experience of the work for which a bid is submitted with CIDB grading of 7CE or 6CEPE or higher. Potentially emerging enterprises who satisfy criteria stated in the Tender Data may submit tender offers.
7. Only tenderers who are registered with CIDB under CE grading or CEPE grading for emerging contractors are eligible to submit tenders.
8. Bid documents must be deposited in the bid box not later than 12h00 on the closing date.
