PROVISION OF BUSINESS RESCUE SERVICES

1. INTRODUCTION

The National Housing Finance Corporation (NHFC) was established by the National Department of Human Settlements as a development finance institution (DFI) in 1996, with the principal mandate of broadening access to affordable housing finance for the low- and middle-income households.

NHFC is a national public entity, the NHFC adheres to the regulatory framework of the Public Finance Management Act (PFMA) of 1999.

The NHFC provides wholesale funding in the affordable housing market mainly to social housing institutions, non-banking retail intermediaries, micro-lenders, privately owned property developers, construction companies and investors. It also provides loans and other form of wholesale funding (equity and quasi equity) to certain niche businesses that are in the affordable housing market.

2. BACKGROUND OF REQUEST FOR QUOTATION (RFQ)

The purpose of this Request for Quotation (RFQ) is to solicit quotations from potential providers of business rescue services and all ancillary statutory required duties related to the business rescue from time to time of companies that are clients of the NHFC and in need of business rescue. The NHFC is looking to appoint two (2) services providers on the Panel of Business Rescue Practitioners.

NHFC offers loans to a variety of companies, usually on a secured basis. At times these companies suffer distress through any number of reasons and the NHFC as the largest creditor may need to place them into business rescue. These companies may be situated anywhere within South Africa.

The NHFC therefore seeks to appoint a panel of business rescue practitioners who are able to be appointed as and when required.

All qualifying business rescue practitioners who apply will be eligible for appointment to the panel on condition they agree to be paid at the rate of the lowest bidder once appointed. When appointing members from the panel to act, the first choice will be the one operating in the same municipality as the company to be placed into business rescue. In the event of there being more than one such company the one with the best B-BBEE score will be appointed. In the event this results in a tie, the selection will be made alphabetically, with the practitioner whose surname is closest to the letter A being appointed first. Once that appointment is made this practitioner will be moved to the end of the queue and if another practitioner is required, it will be the one second closest to A, etc. The selection will thereafter move down the list of B-BBEE scores in the same manner. In the event all qualifying practitioners have had an appointment, the process will commence from the first again.

3. PURPOSE OF REQUEST FOR QUOTATION (RFQ)

The purpose of this Request for Quotation (RFQ) is to solicit quotations from potential service providers for the provision of business rescue services.

4. SCOPE OF WORK/KEY DELIVERABLES

- The provision of a comprehensive business rescue service.
- Extensive solution driven approach to bring an entity to solvency and accounting solution to provide for the repayment of loans ceded to the NHFC.

Proof of registration with the CIPC as a business rescue practitioner is required.

4.1 PROJECT DURATION

- Period of 36 months commencing on the date of the signing the SLA, subject to the appointed service provider meeting all the organization's expectations

4.2 PROJECT COSTS

- Detailed costing aligned to the deliverables should be submitted.
- The proposed project costs must be all-inclusive and in accordance with tariffs provided by legislation.

4.3 LOCKDOWN OPERATIONS PROVISIONS

Kindly note that due to the Lockdown Regulations, NHFC will be operating remotely, therefore service providers should make required provision of virtual meetings.

5. EVALUATION CRITERIA

Price and Preference Evaluation

Bidders will be evaluated in terms of Price and Preference points (B-BBEE status level of contributor). As per the table below, price is evaluated over 80 points and preference points over 20:

- 3.5 There have been no consultations, communications, agreements or arrangements made by the bidder with any official of the procuring institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2017

This preference form must form part of all bids invited. It contains general information and serves as a claim form for preference points for Broad-Based Black Economic Empowerment (B-BBEE) Status Level of Contribution

- 1.5 Failure on the part of a bidder to submit proof of B-BBEE Status level of contributor together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.
- 1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
