1. INTRODUCTION

The Atlantis Special Economic Zone (ASEZ) was officially designated in October 2018. The success of the ASEZ rests on strong collaboration across the public and private sector spectrum. The promulgation of the ASEZ was enabled through collaboration between the Department of Trade and Industry and Competition (DTIC) and Western Cape Government (WCG)'s Department of Economic Development and Tourism (DEDAT), Wesgro and the City of Cape Town (CoCT). Initially inspired by the City of Cape Town's Green Technology Manufacturing Hub, these parties are working together to facilitate the development of the SEZ in Atlantis.

The ASEZ is a keystone initiative that sits within the country's broader green economy industrial development strategy. It thus both supports and draws on these initiatives. Ultimately, Atlantis needs to operate as a viable industrial hub within a thriving green economy and contributing to green technology industrialization and job creation in South Africa. It is an important development intervention tool to unlock green industrial development, manufacturing, employment, technology development, enterprise development and skills development, amongst other opportunities expressed in the green sector strategies, policies and plans of government.

2. SPECIFICATION

Background

The recent COVID-19 pandemic has brought to light the need for food security, as more and more people and communities have become reliant on government grants. The ASEZ has a passion for community, skills and enterprise development work and consequently would like to embark on a Food System and Entrepreneurship Incubation Program, which would serve to educate and empower individuals to increase food security, education about food security, directly linked to employment opportunities.

The incubation program would need to provide individuals/aspiring entrepreneurs with entrepreneurship training programs addressing food security. The incubation program should be designed to develop a generation of small-scale food producers, food distributors and support the development of a localized, sustainable food system.

The goal of the incubation program is to empower current and future entrepreneurs with a thorough understanding of basic business principles (identification of food related business ideas and markets, feasibility studies, effective communication and marketing plans, general business management activities and basic financial management practises). Additionally, the proposed food system solution should assist the successful incubatees with identifying key customers and stakeholders. The successful service provider should clearly demonstrate the proposed practical mentorship methodology and monitoring and evaluation milestones of the incubatees and incubation program in general.

Accordingly, the ASEZ would like to provide an avenue for investment and support, by inviting anyone or businesses to meaningfully respond to the needs of the Atlantis community.

Scope of work:

The service of the incubation program proposal should provide a full project plan with milestones and include:

Access to space & equipment:

- Access to available farming land/ community/ school garden/ demonstration site in Atlantis
- Access to necessary equipment required for successfully starting a local farming production/ demonstration site, together with food production demonstrations will be required from the service provider
- Securing a venue/site for workshops in Atlantis
- Basic refreshments provided for group workshops
- Provision of basic PPE and adherence to Covid-19 regulations

Training and capacity building:

- Basic business operations and management training
- Logistics and distribution basics

- Hands-on training in basic farming practices in peri-urban areas, marketing and selling produce, marketing, understanding of the local agricultural industry and food system, low-cost (indigenous) water storage and irrigation systems, energy saving methods for green houses.

Business incubation support:

- Mentoring and technical business support for building a sustainable food production or related business. (Note that local community has extreme limited access to data and IT devices for online learning platform)
- Establishment of local food system network and provide networking opportunities
- Advisory services on access to production and distribution markets
- Organise and host a small pitch and graduation event upon conclusion of the program

Note that the ASEZ can not cover costs for transport of identified participants in the workshops and incubation program
