2. Scope of Work

The appointed Service Provider shall provide a comprehensive end-to-end Code 14 Driver's Licence Training Programme, including but not limited to the following:

2.1 Learner's Licence Preparation and Testing

The service provider shall:

- Conduct learner's licence preparation classes for all ten (10) delegates.
- Provide learner support material and study guides.
- Facilitate learner's licence application processes.
- Arrange and coordinate learner's licence test bookings.
- Accompany delegates during learner's licence testing where applicable.
- Cover all learner's licence booking and testing fees.

2.2 Code 14 Practical Driver Training

The service provider shall provide either:

- A Full Code 14 Driver Training Course; or
- A minimum of Twenty (20) practical driving lessons per delegate.

The practical training must adequately prepare learners for the Code 14 Driver's Licence Test.

2.3 Driving Test Preparation and Booking

The service provider shall:

- Arrange all official Code 14 driving test bookings.
- Coordinate testing schedules with relevant Driving Licence Testing Centres (DLTCs).
- Cover all test booking fees.
- Provide learner support until completion of the official driving test.
- Truck hire for practical training sessions and for official driving tests.

3. IMPLEMENTATION APPROACH

To minimize operational disruptions and ensure effective learner support, delegates shall be trained in two (2) cohorts as follows:

The service provider shall submit a detailed implementation schedule indicating training dates, learner's licence testing dates, practical driving schedules and final testing arrangements.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
