The appointed service provider will be required to provide, inter alia, the following services but not limited to:

- Hardware and Software warranties from Dasan Zhone for existing GPON equipment.
- Provide additional Dasan Zhone GPON equipment on an Adhoc basis per project.
- Installing new fiber infrastructure on an Adhoc basis per project
- Attend to fiber breaks and complete fiber repairs on an Adhoc basis
- Provide completion certificate after completion for both tangible and intangible assets for inclusion in the asset register.
- Provide Zhone GPON training

## **EVALUATION OF THIS BID**

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points (Specific Goals) will be allocated to the following as included in the bid document:

- I. Enterprises (or bidders) who are at least 51% or more Owned by Black People.
