- 3.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.

4 JOINT VENTURES OR CONSORTIUMS

Respondents who would wish to respond to this RFP as a Joint Venture [**JV**] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Respondents must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV or consortium agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by Foskor through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. 5 COMMUNICATION

- 5.3 Respondents are to note that changes to its submission will not be considered after the closing date.
- 5.4 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Foskor in respect of this RFP between the closing date and the date of the award of the business.
- 5.5 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.
- 5.6 Foskor will publish the outcome of this RFP in the Foskor website with 10 days after the award has been finalised. Respondents are required to check the Foskor website for the results of the tender process. All unsuccessful bidders have a right to request Foskor to furnish individual reasons for their bid not being successful. 6 CONFIDENTIALITY

7 COMPLIANCE

The successful Respondent [hereinafter referred to as the **Supplier/Service provider**] shall be in full and complete compliance with any and all applicable laws and regulations.

8 EMPLOYMENT EQUITY ACT

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

9 DISCLAIMERS

Respondents are hereby advised that Foskor is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Foskor reserves the right to:

- 9.1 modify the RFP's Goods/Services and request Respondents to re-bid on any such changes;
- 9.2 reject any Proposal which does not conform to instructions and specifications which are detailed herein;
- 9.3 disqualify Proposals submitted after the stated submission deadline [closing date];
- 9.4 award a contract in connection with this Proposal at any time after the RFP's closing date;
- 9.5 award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP;
- 9.6 split the award of the contract between more than one Supplier/Service provider, should it at Foskor's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- 9.7 cancel the bid process;
- 9.8 validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Foskor to do so;

Note that Foskor will not reimburse any Respondent for any preparatory costs or other work performed in connection with its Proposal, whether or not the Respondent is awarded a contract.

10 LEGAL REVIEW

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Foskor's Legal Counsel, prior to consideration for an award of business. A material deviation from the Standard terms or conditions could result in disqualification.

11 SECURITY CLEARANCE

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the Goods/Services and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of **CONFIDENTIAL/ SECRET/TOP SECRET**. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

12 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Respondents must register on the CSD prior to submitting their bids. Business may not be awarded to a Respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD.

13 TAX COMPLIANCE

Respondents must be compliant when submitting a proposal to Foskor and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.

The Tax Compliance status requirements are also applicable to foreign Respondents/ individuals who wish to submit bids.

Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

SECTION 3: BACKGROUND AND SPECIFICATIONS OF REQUIREMENTS

1 BACKGROUND

Foskor is one of the world's largest producers of phosphate rock (concentrate) and phosphoric acid. It is one of the world's few vertically integrated producers of phosphoric acid and is the second largest supplier to India, the world's largest consumer of phosphoric acid.

The Company owns and mines phosphate resources and beneficiates the mined material to produce a phosphate concentrate at Phalaborwa, in the Limpopo Province of South Africa. The phosphate concentrate is sold locally and also transported to the Richards Bay plant on the coast of Kwa-Zulu Natal to produce phosphoric acid, sulphuric acid and granular fertilisers MAP and DAP from phosphoric acid and is the leading supplier of fertilisers to South Africa. In all about 95% of the phosphoric acid is exported and the granular sales are divided between exports and local markets. Since 1951 Foskor has supplied more than 95% of South Africa's fertiliser requirements.

2 SPECIFICATIONS AND REQUIREMENTS

- a) The Lowbed horse and trailer offered must comply with the following standards of safety:
 - i. The Mines Health and Safety Act and Regulations, 29/1996
 - ii. The National Road Traffic Act and Regulations, 93/1996
 - iii. The National Transport Act and Regulations, 74/1977
 - iv. All relevant SAE, ISO and SANS standards
- b) The lowbed trailer must have a minimum payload (**Cargo**) capacity of **100,000kg.(100 Tons)**
- c) Lowbed horse and trailer to be supplied with a securely fitted spare wheel, jack and wheel spanner.
- d) Lowbed horse to be fitted with an "**automatic shift**" gearbox.
- e) Lowbed horse and trailer to be supplied with a set of emergency warning triangles. Triangles to be in accordance with the National Road Traffic Act
- f) Lowbed horse and trailer light circuit to be altered in such a manner that when vehicle is started, the illumination light circuit is **automatically** energised (Main beam dim-, park- and rear taillights) when the vehicle ignition is in the ON position, and when vehicle ignition is in the OFF-position the illumination light circuit is **automatically** switched OFF (Main beam-, park- and taillights OFF). Vehicle must be started for main beam-, park- and taillights to work.
- g) Lowbed horse and trailer to be fitted with a lockable master switch (Bosch 4 pole master switch and isolator locking bracket Trysome part.T170015403) to disconnect negative side of battery. Switch to be mounted within the engine compartment and be easily accessible for quick isolation.
- h) Main and working lights must to be HELLA LED lights and must provide adequate lighting for safe night time operation.
- i) Taillights, stop lights, hazard lights and directional indicators must be HELLA LED lamps.
- j) (The following groups supply Automotive LED globes: HELLA, AC/DC Dynamics, Electro Diesel Group, TRYSOME, and FARASONN Auto Electrical)
- k) Taillights to be fitted with rugged metal guards. Guards to be affixed with corrosion resistant screws. (Guards are not to be riveted on)
- l) Lowbed to be provided with rear facing HELLA LED flood lights mounted on the roof of the horse for safe night time loading and load securing operation. Independent ON-OFF switch to be mounted in the cab. Electrical wiring must be concealed and neatly routed within body panels and compartments.
- m) Lowbed horse and trailer electrical horn must be clearly audible at a distance of at least 90 meters.
- n) Lowbed horse and trailer to be fitted with an electrical back-up warning device (ECCO 787). The intermittent sound must be clearly audible at a distance of at least 90 meters.
- o) Lowbed horse and trailer to be fitted with a lockable fuel cap.
- p) Batteries to be Deltec or Energizer maintenance free.
- q) Mud flaps to be fitted in front of each wheel (Front and rear) to prevent mud being splashed onto the lowbe horse windscreen and side windows. Mud flaps to be securely fitted to the lowbed horse and trailer body with corrosion resistant setscrews. Mud flaps must clear the road surface by exactly 200 mm.
- r) Lowbed horse and trailer to be supplied with a set (2) of stop-blocks (chock-blocks):
- s) Stop-blocks to be manufactured from all-weather heavy-duty material. Color bright yellow.
- t) Stop-blocks to fit wheel radius snugly and be suitable for the LOWBED HORSE AND TRAILER .
- u) Stop-blocks to be securely mounted in a heavy-duty steel bracket mounted on the driver's side of the lowbed horse in an unobstructed location and must be easily accessible.
- v) Stop-blocks to be fitted with non-slip pads and a handle for easy handling.
- w) Lowbed horse to be fitted with a 9.0kg charge, dry powder, 40% Mono Ammonium Phosphate, 45% Ammonium Sulphate and 0% Calcium Carbonate based fire extinguisher with scrubber valve behind gauge. Fire rating 3A:38.:

- i. Fire extinguisher to be SABS approved.
 - ii. Fire extinguisher to be mounted behind the cab on the driver's side in a sturdy, quick release bracket and be easily accessible.
 - iii. Quick release bracket must be supported at the back and foot end.
 - x) Lowbed horse to be fitted with a splash guard to ensure that engine and radiator is protected from mud and road debris.
 - y) Tail lights to be fitted with rugged metal guards. Guards to be affixed with corrosion resistant screws. (Guards are not to be riveted on)
 - z) A pipe, 500mm long with an ID of 20mm to be securely mounted at the driver's side of the lowbed horse in a vertical position wherein a fibreglass flagpole (buggy whip) can be placed.
 - iv. Pipe to be closed at the bottom with water drain hole.

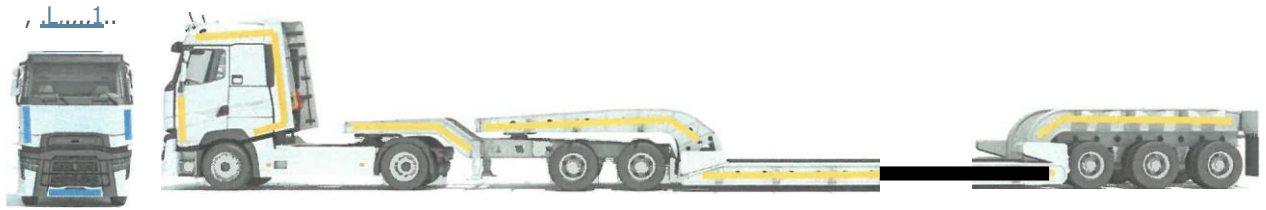

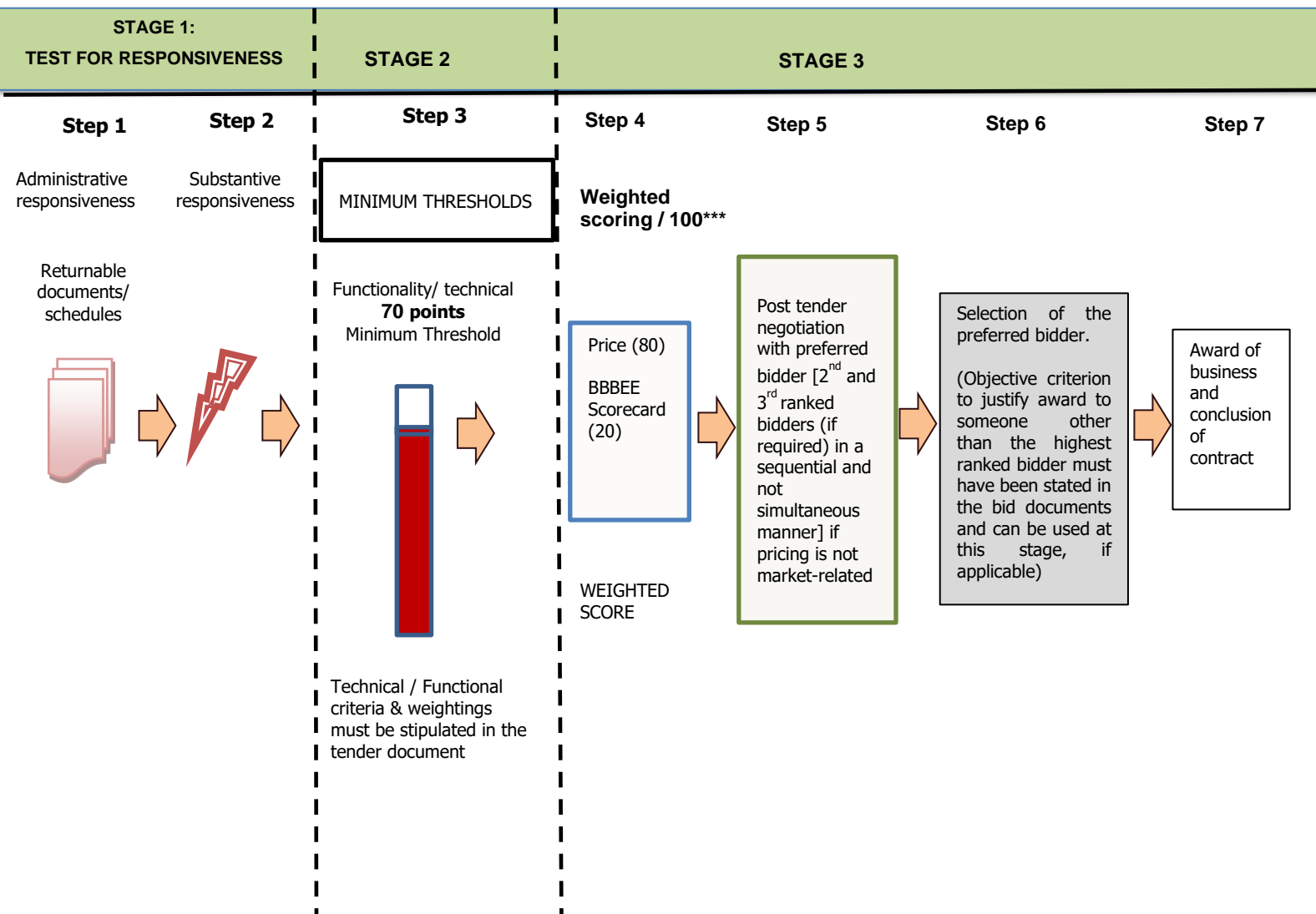

THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME**INTRODUCTION**

The National Industrial Participation Programme (NIPP), which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997.
