1. PURPOSE

To appoint a facilitator to conduct a workshop on 27 November 2023 at the Skukuza with youth thought-leaders as part of the Vision2040 project.

2. BACKGROUND

The South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity)

The need to change the strategic direction and operations of the organisation was acknowledged early in 2022 by the leadership of SANParks. Amongst others, it was noted that for SANParks to remain relevant and sustainable for the future the SANParks leadership is determined, committed and excited to develop SANParks Vision 2040. A collaborative, inclusive process that will re-imagine and co-create a new future for conservation in and through national protected areas.

In June, a group of approximately 50 youth gathered in Skukuza to discuss the future of the organization, their thoughts around the future of conservation and related matters. A workshop report has been prepared capturing those inputs.

3. SCOPE OF WORK

The selected facilitator will be responsible for the facilitation of the 1-day workshop with the following objectives and tasks:

The key outputs will be:

1. The facilitation of the workshop to achieve the objectives above,
2. Break some of the thought patterns, raising current thinking to futures thinking,
3. Critically engage the group and build excitement and a sense of ownership in Vision2040,
4. Solicit actions points and suggestions and recommendations for simple actions that the youth can take to contribute to the future of national parks. These could be focused on things they can do personally or within their school or community.
5. Capture inputs during the meeting for SANParks' later use.

4. INNOVATIVE APPROACH

The facilitator will have to show the ability to work with youth and utilize innovative tools to engage the youth. These may be any of the following:

- o Visual storytelling
- o Storytelling and role-playing
- o Group discussions and brainstorming sessions
- o Visual Creations
- o Storytelling
- o Group discussions and Ideas

Costs associated with the approach utilized above, should be included in the bid amount.

5. ROLES AND RESPONSIBILITIES OF SANPARKS

SANParks will provide/ perform the following functions:

- Book the venue i.e. the Skukuza Conference Centre, with standard workshops facilities such as flipcharts and overhead projectors as well as tea, refreshments and meals,
- Invite the participants and cover their costs where required,
- Book and pay for the travel (flights and car rental) and accommodation of the facilitator and one (1) other individual, to and from Skukuza Airport or Mpumalanga Airport depending on availability and accommodation for 2 nights at Skukuza Lodge or Kruger Gate depending on availability.

6. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
