BACKGROUND

On 24 February 2026, TCTA formal request from the Minister of Water and Sanitation, via the Board Chairperson, to support top-performing schools in Sterkspruit and Aliwal North—rural farming communities in the Eastern Cape with vulnerable learners facing significant socio-economic challenges. In response to the Minister’s request, TCTA pledged to provide support to the three top schools, with a 100% pass rate, as listed in the Minister’s letter. The pledged support encompassed three bursary opportunities for top students among these schools and a supply of school shoes and tracksuits. The organisation is mandated to donate tracksuits to Aliwal North Technical Orientation School and Phambili Mzonntsundu School. The initiative reflects TCTA’s commitment to supporting vulnerable groups within communities affected by its projects and aligns with the organisation’s broader objective of creating sustainable social impact beyond infrastructure development.

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender.
