1. BACKGROUND

City of Tshwane Metropolitan Municipality is expected to comply with the International Accounting Standards 19(IAS 19) and Generally Recognised Accounting Practice 25 (GRAP 25) in terms of disclosure of employee obligations.

Employees' benefits include any benefits that employees are entitled to in rendering the service. Valuations of employee benefits, particularly under IAS 19 and GRAP 25 should be performed by actuaries who are qualified professionals specializing in actuarial science.

City of Tshwane seeks actuarial services for valuation of employee benefits for the 2025/26 financial year and will issue a request for Quotation in that regard.

2. PROJECT SCOPE

This quotation seeks to appoint an Actuarial Company to render actuarial services to the City of Tshwane in terms of the requirements of the International Accounting Standards 19(IAS 19) and GRAP 25 for financial year 2025/26 relating to post employee benefits.

3. DELIVERABLES

31. Gratuities

The municipality has an obligation to pay Gratuity to qualifying employees appointed on or before 1998 against the CCP (City Council of Pretoria) conditions

of services, who at that time did not belong or might still not belong to pension or provident fund.

Actuarial valuations should be performed for this benefit.

There are 12 members at 31 March 2025.

3.2 Pension defined Benefits and Multi-employer plans

The defined benefits in a pension fund are the predetermined benefits that are guaranteed to members of the pension funds. The municipality and the members jointly contribute to the fund and if there is a shortfall towards the benefits for the members, the employer must pay the shortfall or an additional subsidy to meet the amount to be paid to members on retirement. Actuarial valuations should be performed for all the defined benefits plans within the municipality and disclosure of all other multi-plans.

Valuations to disclose liabilities covered by the municipalities in case of defined benefits funds **shortfalls** as per the rules of each defined benefit fund.

There are 1900 members at 31 March 2025.

3.3 Long Service Awards

The municipality has an obligation to pay employees accumulated long service award to qualifying employees as per the long service award policy. The award is payable monthly or at termination of service. Actuarial valuation should be performed for these benefits.

There are 17500 members at 31 March 2025.

3.4 Continued Medical Membership

The municipality has an obligation to pay continued medical aid membership subsidy to qualifying employees who go on retirement, subject to certain conditions. The subsidy amount payable for this benefit is between 60% to 70% of the total contribution with a curbing amount of R5 514.86 as per the applicable salary/wage collective agreement of the year under review -1 January 2025 to 31 December 2025 and is reviewed annually according to the outcome of the collective agreement and annual increase negotiations.

Employees who have left the service of the City of Tshwane due to injury on duty also receive a medical aid subsidy.

There are 1850 members at 31 March 2025.

The above valuations must be calculated for municipal financial year starting from 1 July 2025 to 30 June 2026.

 - as well as qualify as Retirement Fund Valuers accredited by the Financial Sector Conduct Authority (FSCA).

Certificates from both ASSA and FSCA should be attached.

2. Senior Manager qualification in actuarial science and relevant 4 years of experience (Attach Curriculum Vitae clearly demonstrating the experience in managing valuation of retirement funds project/s).
3. Company's previous 3 projects completed in actuarial science, specifically valuation of retirements funds. For each project or service performed, please provide contactable **reference** letters relevant to the contract/service signed and in the company letterhead.

Stage 3: PREFERENCE POINT SYSTEM

The preferential point system used will be the 80/20 points system in terms of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Regulations 2022.

- 80 points for price
- 20 points for Specific goals

7. MARKET ANALYSIS

The City of Tshwane reserves the right to conduct market analysis. Should the City exercise this option, where a bidder offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the bidder to seek confirmation of whether the bidder will be able to deliver on the price, if a bidder confirms that they cannot, the bidder will be disqualified on the basis of being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the service provider to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a bidder scoring the highest points. If the bidder does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the bidder scoring the second highest points, if the bidder scoring the second highest points does not agree to a market-related price, the City will negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the City reserves the right to cancel the quotation.
