1. BACKGROUND

1. BACKGROUND

- 1.1. The Banking Sector Education and Training Authority (BANKSETA) is a statutory body established through the Skills Development Act of 1998 as amended by the Skills Development Act, 26 of 2011 to enable its stakeholders to advance the national and global position of the banking and alternative banking sector. The BANKSETA is the sector education and training authority for the banking and alternative banking sector. As guided by its mandate, the BANKSETA is as such an agent of transformation and seeks to promote employment equity and broad-based BEE through skills development.
- 1.2. The Public Administration Act, No 11 of 2014 states that the head of the public institution shall:

 (a) acquire and use information and communication technologies in a manner which— (i) leverages economies of scale to provide for cost effective service; (ii) ensures the interoperability of its information systems with information systems of other institutions to enhance internal efficiency or service delivery; (iii) eliminates unnecessary duplication of information and communication technologies in the public administration; and (iv) ensures security of its information systems. (b) use information and communication technologies to develop and enhance the delivery of its services in the public administration. (c) align the use by staff of information and communication technologies to achieve optimal service delivery; and (d) promote the access to public services using information and communication technologies
- 1.3. The BANKSETA, therefore, seeks to procure a network monitoring tool for monitoring of the computer network as one way to ensure security of its information systems.
- 1.4. The BANKSETA computer network has (i) 80 x laptops, (ii) 9 x switches, (iii) 1 x firewall, (iv) 3 x physical servers running windows server, 7 x virtual servers.

2. SCOPE

2.1 BANKSETA intends to appoint a suitably qualified, competent, and capable service provider to supply, deliver, install and configure a network monitoring tool that has the following specific capabilities:

2.2 Discover and Map devices on the network

- 2.2.1 Discover and map everything connected to the computer network
- 2.2.2 Auto-generate interactive Layer 2 and 3 topology maps.
- 2.2.3 Dynamically update maps as changes occur on the computer network
- 2.2.4 Detect and visualize device dependencies
- 2.2.5 Customize maps with images, text and links

2.2.6 Monitor devices on the network

- 2.2.6.1 Enable problems find and fix
- 2.2.6.2 Assure bandwidth is optimized for critical apps and services
- 2.2.6.3 Automate configuration, log and asset management
- 2.2.6.4 Maintain, audit and restore device configuration

2.2.7 Monitor Device utilization

- 2.2.7.1 CPU Utilization
- 2.2.7.2 Disk Utilization
- 2.2.7.3 Memory Utilization

2.2.8 Monitor Cloud environment (Microsoft Azure)

- 2.2.8.1 Discover every element of Azure cloud environment and view on the network map
- 2.2.8.2 Enable use of monitoring tool to every single parameter supported by Azure cloud APIs
- 2.2.8.3 Identify cloud and on-premises network issues
- 2.2.8.4 Monitor and report on cloud billing

2.2.9 Automated Network Configuration and Change Management

- 2.2.9.1 Automate configuration and change management for routers, switches and firewalls on the network.
- 2.2.9.2 Archive and audit network configurations.
- 2.2.9.3 Ability to generate alerts to changes.
- 2.2.9.4 Ability to compare versions side by side with discrepancies highlighted.

2.2.10 Integration to:

2.2.10.1 Microsoft Teams

2.2.11 Software licenses

2.2.11.1 One year license

2.2.12 Workshop and skills transfer

2.2.12.1 Provide skills transfer to three (3) ICT personnel on installation and operation of the network monitoring tool.

3. Contract duration

3.1 The Service Provider must provide the software license for one (1) year.

4. MINIMUM REQUIREMENTS

- 4.1 Company experience / reference letters
 - 4.1.1 Experience (reference letters x 3) in provision of computer network monitoring tool
- 4.2 Network certifications (CCNA, HP Aruba, Comptia Network + or equivalent).
 - 4.2.1 CV for information security personnel with at least 3 years in Network Monitoring.

5. PRICE AND BBBEE

The preferential procurement point system applicable for this process is 80/20, as approved by the BANKSETA Board.

The RFQ will be evaluated based on the 80/20 principle being:

80 Points for price and 20 points for BBBEE

The BBBEE Certificate or a Sworn Affidavit for the exempted bidders to be attached.

6. COMPLIANCE STATUS

- a. The BANKSETA before making an award, shall check on the Central Supplier Database CSD whether;
- a) the bidder's tax status is compliant and
- b) the bidder or any of its directors are not listed / indicated as restricted from doing business with the public sector, and/or are person(s) prohibited/ its directors are not employees of the state and have no conflict of interest in the BANKSETA, or have written authority to do work with the state as per the legislation.
- b. The BANKSETA will not award to service providers who do not comply with the above.

7. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTOR

In terms of Regulation 6 (2) and 7 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

The points scored by a bidder in respect of the B-BBEE contribution will be added to the points scored for price in order to arrive at the overall score.

Points will be rounded off to the nearest 2 decimals.

In the event that two or more RFQs have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for the specified goals or B-BBEE contribution.

8. RFQ CONDITIONS

- a. BANKSETA reserves the right to withdraw or amend terms of reference by notice in writing by advertising in the media in which the RFQ was originally advertised prior to the closing date.
- b. BANKSETA reserves the right not to award this RFQ and the right to reduce the quantities awarded.
- BANKSETA reserves the right to verify the information submitted and request for further information during evaluation of the proposal.
- d. BANKSETA shall not be liable for any direct, indirect, consequential or other losses or damages including loss of profit that may be incurred by any person including, but not limited to, an Applicant, Short Listed Applicant or Successful Applicant, or any director, officer or associated company thereof, as a result of any reliance on or use of information supplied in response to this RFQ or as a result of the RFQ process contemplated in this RFQ document.
- e. BANKSETA makes no representations, undertakings or warranties whatsoever to any person in respect of the RFQ or any information contained in the RFQ.

- b. All applications duly lodged as per the submission requirements will be evaluated in accordance with the stipulated evaluation criteria.
- c. The validity period of proposals is **60 days** after closing.

10. REASONS FOR REJECTION

- a. Applicants shall not contact BANKSETA on any matter pertaining to the application from the time the application is closed to the time the application has been adjudicated..
- b. BANKSETA shall reject a submission if the applicant has committed a proven corrupt of fraudulent act in competing for a particular contract.
