This bid is evaluated through a three (03) stage process			
<u>Stage 1 – Compliance to Technical Mandatory Requirements (refers to Table 2 below) including Returnable Document Checklist refers to Table 1 above, (Mandatory as these are GO/NO GO gates, comply/not comply</u> Bidders warrant that their proposal document has, as a minimum, the specified documents required for evaluating their proposals. On the table above, the LGSETA provided the Returnable Document Checklist listing these including which documents are GO/NO GO to the bidders.			
The LGSETA evaluates only procurement responses that are 100% acceptable in terms of the Returnable Document List. The LGSETA will disqualify bidders who are found not compliant with this list as per table 1 above. Only Bidders who proceed further for stage 2 it will be for those who are compliant to the mandatory requirements			
<u>Stage 2 – Evaluation of Bids against Specifications and Quality</u>			
The LGSETA evaluates each bidder's response to the specifications issued in accordance to published evaluation criteria and the associated scoring set outlined in this bid invitation.			

The LGSETA will, where circumstances justify it, request evaluation sessions such as interviews/presentations/site-visit/pitching sessions/proof of functionality sessions with short-listed bidders before concluding the evaluation. These sessions will form part of the evaluation and by no means indicate that the bidder is officially appointed.

Only bidders who achieved the minimum predefined **functionality/quality threshold of 80 points** will be put through to Stage 3, the remaining bidders will be disqualified from further evaluation/consideration.

Stage 3 – Price/Preference Evaluation

The LGSETA intends to appoint an additional panel of specialists up to a maximum of five (5) bidders per Category. As such, the bidders who get to Stage 3 will be evaluated and ranked and the top scoring bidder (except where there are reasons for pass-over) will be appointed per each category.

The LGSETA compares each bidder's pricing proposal on a fair and equal basis taking into account all aspects of the bids requirements. The LGSETA ranks the qualifying bids on price and preference points claimed in the following manner:

Price - with the lowest priced Bid on an equal and fair comparison basis receiving the highest price score as set out in the Preferential Procurement Policy 2017 Regulations;

Preference - preference points as claimed in the preference claim form (SBD6.1) added to the price ranking scores; and

The LGSETA recommends the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation. LGSETA may still appoint a bidder other than the bidder who scores the highest score points in stage 3 with sufficient and justifiable reasons.

Bid Procedure Conditions:

Counter Conditions

The LGSETA draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

Response Preparation Costs

The LGSETA is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

Cancellation Prior To Awarding

The LGSETA reserves the right to withdraw and cancel the Bid Invitation at any time prior to the delegated official making an award.

Collusion, Fraud And Corruption

Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.

Fronting

The LGSETA, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should any of the fronting indicators as contained in the "Guidelines on complex Structures and Transactions and Fronting", issued by the Department of Trade

OVERVIEW OF THE LGSETA

The Local Government Sector Education and Training Authority (LGSETA) is a public entity established in terms of Section 9(1) of the Skills Development Act, No 97 of 1998. The Mandate of the LGSETA is to facilitate skills development for local government sector. The Local Government Sector Education and Training Authority (LGSETA) is a statutory body established in terms of the Skills Development Act (No. 97 of 1998) as amended, to advance skills levels in accordance with the National Skills Development Plan.

BACKGROUND OF THE PROJECT

The Local Government Sector Education and Training Authority (LGSETA) invites suitable qualified and experienced service providers/individuals to submit proposals to register as Learning Programme Evaluators on the LGSETA's panel of preferred service provider. The evaluators will evaluate qualifications and learning programmes falling within the LGSETA scope of accreditation. The reason for evaluations is to enable providers to attain LGSETA accreditation and to ensure that learning material is in line with SAQA learning programme design. The successful bidders will be required to report daily, weekly and monthly to the ETQA manager and/or ETQA practitioner. The Learning Programme Evaluators will be responsible for evaluating learning programmes submitted by potential Skills Development Providers who wish to be accredited by the LGSETA.

LGSETA will not appoint a programme evaluator who is currently accredited by the LGSETA and the appointed evaluator will not be allowed to be accredited with LGSETA for the duration of the contract or the appointed evaluator must voluntarily terminate the contract awarded to them by the LGSETA before application for accreditation can be submitted to the LGSETA. Bidders are to note that a position on the panel is no guarantee that the Bidder will receive brief (s) from LGSETA.

SCOPE REQUIRED

The evaluators must have expertise in the evaluation of qualifications which are listed on table 1 page 11.

LGSETA will only consider bidders/evaluators who are able to evaluate all qualifications within a chosen category group, failure to provide all qualification within a group/category will result in disqualification on that category. LGSETA may appoint a service provider in more than one category but LGSETA reserves the right to exercise its sole discretion in allocating categories should a service provider be successful in more than two categories. LGSETA may appoint the said service provider in the first highest scored categories and allocate other categories to the next highest scoring bidder.

The objective of this tender is to identify and appoint additional panel of specialists up to maximum of five (5) per specific area of specialization including already appointed evaluators (Category, A, B, C, D, E, F and G) whose services may be utilized by LGSETA.

Please follow table 1 for grouping and to determine the sub-category.

Brief per areas of specialization may be allocated as per number of learning programmes received by the LGSETA due for evaluation.

THE EVALUATORS WILL BE REQUIRED TO DO THE FOLLOWING:

- i. Conduct all learning Programme evaluation on site at the LGSETA office in Bedfordview or LGSETA provincial offices or work from place of residence.
- ii. Provide capacity building from time to time to prospective skills development provider/s and or ETQA staff when the need arises.
- iii. Evaluate learning material for learning programmes that are aligned to the LGSETA primary focus area (see attached appendix of LGSETA primary focus area).
- iv. Avail themselves as and when required, to conduct programme evaluation.
- v. To evaluate the content of learning programmes submitted by skills development providers seeking accreditation or programme approval or extension of scope within the LGSETA primary focus, in line with SAQA and QCTO requirements
- vi. To identify areas of development for skills development providers and to provide developmental plans, with clear timeframes when the learning programme evaluation report is issued out for remedial.
- vii. To generate quality reports with clear recommendations on accreditation/ programme approval status to be granted to providers. The reports must be completed on templates designed by the LGSETA for this purpose.
- viii. The evaluators will be required to enter into a fixed term contract at the discretion of the LGSETA.
- ix. The appointed evaluators must have their own reliable transport, computers/laptop and internet connectivity.
- x. In the event that a company is appointed, the person whose CV was submitted as part of the evaluation criteria number 3 (**Human Resource Capability**) below, must be the person assigned to evaluate the learning material applied for. In the event such a person resigns from the appointed company, the person must be replaced with a person with similar experience and qualification, LGSETA will need to approve a new resource. LGSETA will reject utilization of inexperienced person and this will result in the cancellation of the contract.

In this particular call, tenders scoring at least **80 points out of 100** will be classified as technically acceptable and will be submitted to financial evaluation.

Tenders which are technically acceptable and eligible to participate in this part of evaluation are next awarded financial points. Maximum points are awarded to the lowest-priced tender.

The evaluation of service provider's responses will be based on the following weighting of the proposals will be evaluated on a scale of 0-3 in accordance with the criteria below.

The rating will be as follows: 0= No submission/less than LGSETA requirements/Poor, 1 = Average, 2 = Good, 3 = Excellent
