2. SCOPE OF WORK

NRWDI seeks to appoint a supplier who will supply a Video Conferencing Solution and Installation.

The National Radioactive Waste Disposal Institute (NRWDI) currently does not have a dedicated video conferencing solution to support effective stakeholder communication and engagement across its facilities. This includes one boardroom at the Head Office in Pretoria and one boardroom at the operational site in Vaalputs.

With the recent granting of the Operational License (NIL43), it is essential that NRWDI enhances its communication infrastructure to effectively execute its mandate of providing sustainable and technically feasible solutions for the national management and disposal of all classes of radioactive waste.

A reliable video conferencing solution will enable seamless collaboration between the head office, operational site, and key stakeholders across the country. This will facilitate:

- Efficient coordination and decision-making between geographically dispersed teams.
- Enhanced engagement with regulatory bodies, government departments, and industry partners.
- Cost savings through reduced travel and associated logistics; and
- Business continuity and operational efficiency, especially in remote or restricted-access environments.

This solution is therefore critical to strengthening NRWDI's operational capacity, improving stakeholder communication, and ensuring the effective execution of its mandate.


EVALUATION CRITERIA

1. Mandatory Requirement (At RFQ Closing Date)

- i. Suppliers who fail to quote fully or according to the price structure/table and scope of work will be disqualified (refer from page 1-4)
- ii. Quotation submitted after the closing date and time will not be considered for evaluation.
- iii. Quotations that are not sent through the procurement central email will not be considered for evaluation.
- iv. Submit a minimum of three reference/recommendation letters from previous clients where a video conferencing solution was supplied and installed.

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/documentation stated in the conditions of this tender:
