Background

Research Testing and Development undertakes routine biomonitoring surveys at all of its coal fired power stations.

Biomonitoring assessments of the water resources surrounding Eskom properties are crucial to identify potential impacts to the aquatic environment. Research is undertaken in order to mitigate harm to the environment due to Eskom activities; prevent costly remediation measures; and, assist the business to improve from a reactive to proactive management of the interactions.

The main purpose of the biomonitoring programme is to serve as a source of information regarding the overall ecological status of river ecosystems around Eskom power stations. Biomonitoring surveys are conducted bi-annually in summer and winter every year. Chemistry analysis, macro- invertebrate, habitat, fish and toxicity assessments are performed at sites around the Arnot, Camden, Duvha, Grootvlei, Hendrina, Kendal, Komati, Kriel, Kusile, Lethabo, Majuba, Matimba, Matla, Medupi and Tutuka power stations as well as the Underground Coal Gasification (UCG) sites. Reports are issued to individual power stations as part of their water license requirements.

The assessment of Eskom's operational influence on the aquatic ecosystems surrounding the power stations enables Eskom to comply with legislation; individual Water Use License (WUL) requirements, and to take a proactive step towards water quality management, by identifying water quality trends of surface water resources Eskom surrounding Eskom properties.

Due to the current human resource constraints being experienced, Eskom Research Testing and Development (RT&D) does not currently have the capacity and skills necessary to analyse the data and compile the survey reports. It is therefore necessary to contract this portion of the work to a suitably qualified consultant.

In addition, in order to develop in-house skills with new staff recruits training is required on all aspects of on-site biomonitoring.
