The scope of work will include the purchase, collection and removal of **SCRAP KVA TRANSFORMERS AND MINI-SUBS** within Eskom **GEMMA CLUSTER (North West)**.

- The successful tenderer will be required to pay upfront for the allocated batch of **232** transformers and collect all units within 7 working days from the issue date of the approved work instruction / task order.
