PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. INTRODUCTION

The South African Diamond and Precious Metals Regulator (SADPMR) is located at Corner Bonaero Drive and Cote D Azur Avenue, Kempton Park, 1622.

The server hardware environment runs on HP Synergy platform and utilising Microsoft Hyper-V virtualization and clustering technologies. The storage environment needs to be expanded without compromising the existing services.

2. PROJECT OBJECTIVE

The SADPMR requires the current SAN cluster storage to be expanded. The new hard drives must be integrated into the existing storage and be accessible and useable through Hyper-V Cluster Manager. The hard drives must also be updated to the latest firmware. Two servers must be rack-mounted and must run Windows Server operating system. The solution must be fully operational to the best industry standards.

4. PROJECT PLAN AND OUTCOMES

An end to end, fully functional blade server solution with Virtualisation and Central Storage infrastructure with Data Centre compliant technology. The installation and upgrade of the hard drives should reduce the

risk of migration of current applications and data to ensure that all business and operational systems will be available with minimal disruption to the business.

9.3.2. The points scored for the specific goal must be added to the points scored for price and the total must be rounded off to the nearest two decimal places.

9.3.3. Final appointment to be awarded to the tenderer scoring the highest points.
