In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for APPOINTMENT OF A PANEL OF MAXIMUM 5 (FIVE) SMME'S (CONTRACTOR DEVELOPMENT) FOR THE CONSTRUCTION OF STORMWATER DRAINAGE SYSTEM, PAVING AND KERBING AROUND MP313 AS AND WHEN REQUIRED FOR A PERIOD OF THIRTY SIX (36) MONTHS , in the Steve Tshwete municipal region. **Tenderers should have a CIDB contractor grading of 1CE, 2CE or 3CE.**

Only payments made in cash or debit/credit card will be accepted.

The tenders will be opened in public.

A compulsory clarification meeting will take place on 14 April 2026 starting at 10:00, in the Electrical Workshop Boardroom, Municipal Stores (Magasyn), Cnr Walter Sisulu & Protea Street, Middelburg, 1050.

*Bidders will be evaluated on functionality whereby **70 points** has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where **80 points** will be allocated in respect of price and **20 points** in respect of Specific Goals. Tenderers must have the necessary skills, experience and capacity to perform the required work.*

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person , of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

- **Copy(ies) of share certificate(s) and certified copy of medical certificate (where necessary) – Non-Compulsory (failure to submit no points will be awarded)**

- **Copy of current municipal account (not older than 3 months) or copy of Lease Agreement (and Landlord's municipal account) – Compulsory**

- **Joint Venture Agreement (In case of a Joint Venture) – Compulsory**
- **Joint Ventures must be registered on CSD as Joint Venture**

- **CIDB grading of 1CE, 2 CE or 3CE – Compulsory**
- **Valid COIDA Letter of good standing/Workmen’s Compensation Registration Certificate – Compulsory**
- **Audited Annual Financial Statements for the last three (03) Financial Years – Compulsory**
- **All forms must be filled in full – Compulsory**
