1. INTRODUCTION

- a. This bid is for the supply and delivery of patient simulation training hardware, software, consumables, and maintenance, to the Free State Department of Health.
- b. The contract has a tenure of 3 years.
- c. Receipt of the invitation to bid does not confer any right on any party in respect of the services or in respect of, or against, The Free State Department of Health reserves the right, in its sole discretion:
 - To withdraw any services from the bid process, to terminate any party's participation in the bid process or to accept or reject any response to this invitation to bid on notice to the bidders without liability to any party; accordingly, parties have no rights, expressed or implied, with respect to any of the services as a result of their participation in the bid process.
 - To amend the bid process, closing date or any other date at its sole discretion, to cancel the bid or any part of the bid before the bid has been awarded,
- d. No quantities will be reflected in the bid and no guarantee will be given or implied as to the actual quantity which will be procured during the contract period
- e. Supplier must submit proof for each product of which they are the Sole Supplier in South Africa as specified in the bid document.
- f. Descriptive literature, technical specifications, brochures or pamphlets must be provided with the Bid document with sample evaluation. Failure to submit will invalidate the item.

2 LEGISLATIVE AND REGULATORY FRAMEWORK

This bid and all contracts emanating from it will be subject to the General Conditions of Contract (GCC) issued in accordance with Treasury Regulation 16A published in terms of the Public Finance Management Act (PFMA), 1999 (Act 1 of 1999) as well as the Preferential Procurement Policy Framework Act 2000 (PPPFA) with its latest 2017 Regulations. The Special Conditions of Contract (SCC) are supplementary to that of General Conditions of Contract. However, where the Special Conditions of Contract conflict with the General Conditions of Contract, the Special Conditions of Contract prevail.

3. SPECIFICATIONS AND SCOPE OF WORK

The detailed item specification is as per the attached Technical Specification read in conjunction with the schedule of requirements.

4. MANDATORY AND OTHER STANDARD BIDDING DOCUMENTS REQUIREMENTS

Bidders must submit all required documents indicated hereunder with the bid documents at the closing date and time of the bid. During this evaluation phase, bidder's responses will be evaluated based on the documents submitted under mandatory requirements. Bidders who fail to comply with any of the mandatory criteria will be disqualified.

4.1.1 Standard Bidding Documents

5. AUTHORISATION DECLARATION / MANUFACTURER

It will be required from the bidders who are not original suppliers to supply a guarantee from the original suppliers of the equipment that all parts used be compatible with the equipment. For this reason, bidders must include proof from the original suppliers of the equipment that the original suppliers are willing to supply parts used by the bidder.

6. PRICING STRUCTURE AND SCHEDULE

- a) One price is required, and prices quoted must be furnished on the basis of supply and delivery to the ordering institution including VAT. Prices submitted will be only for the first year, following years will be submitted annually as an addendum for price adjustments, based on the average CPI.
- b) The pricing schedule provided in this bid forms an integral part of the bid document and bidders must ensure that it is completed without changing the structure thereof.
- c) Prices submitted for this bid must be filled in on the field provided on the pricing schedules supplied with the bid.
- d) The SBD3.2 will be the hard copy version of the pricing schedule and will be the legal document.

7. TAX COMPLIANCE REQUIREMENTS

8.1.1 Standards/Specifications

8.1.3 Marking of Samples

- a) Samples must be clearly marked with the bid number, item number(s), and the bidder's name. These details must appear on an outer package of the product to make it easier to identify the product.
- b) Samples must be placed in suitable containers and be clearly marked on the outside with the bid number, item number(s), and the bidder's name. This detail must appear on a label attached to each individual item package.
- c) Samples must not be expired for sample evaluation / testing. **Expired samples will invalidate item.**

9. RIGHT OF AWARD

The Free State Department of Health reserves its following rights:

- a) Request further technical information from any bidder after the closing date.
- b) Verify information and documentation of the service provider.
- c) To withdraw or amend any of the bid conditions by notice in writing to all bidders prior to closing of the bid and post award; and
- d) In the event that an incorrect award has been made to remedy the matter in any lawful manner it may deem fit.

10. LATE BIDS

Bids received after the closing date and time by the Bid Management will NOT be accepted for consideration and where practicable, be returned unopened to the bidder.

11. COMMUNICATION AND CONFIDENTIALITY

- a) The accounting officer may give permission to communicate with bidders where clarity is sought after the closing date and time of the bid and prior to the award of the contract, or to extend the validity period of the bid, if necessary.

ITEM 1 : Advanced Training/ Simulation Manikin	<p>The manikin must be full human size and anatomically correct. The limbs of the manikin must be fully articulating on both shoulders, elbows, wrists, hips, knees, and ankles. The "skin" of the manikin must be made of high durability silicone that allows for multiple needle piercings and minimal damage to skin. A minimum of 500 piercings must occur before replacement of any skin is required. The manikin must have dedicated sites for the insertion of Intra Osseous needles on the leg, shoulders and, if possible, the chest with dedicated drainage bags that can attach to these systems. The "bones" that is used to drill into must be replaceable. The arms must have dedicated intravenous insertion sites which must be able to accommodate all sizes of intravenous needles. The intravenous sites must have drainage sites where a collection bag can be connected to. The trachea of the manikin must be able to accommodate surgical airway techniques with accurate anatomical landmarks with a replaceable neck skin. The facial structure of the manikin must allow for manual airway manoeuvres to be done as well as being realistic to include blinking eyes, pupils which can dilate and constrict, sweat glands on face and open nostrils.</p> <p>The following items must be standard on the manikin:</p> <ul style="list-style-type: none"> > Have internal batteries to operate when not plugged into power. > Have internal mechanisms to realistically simulate respirations. > Have speakers on the chest and abdomen to use for auscultating lung, heart and abdominal sounds. > Have the ability to inflate the abdomen. > Must have a mechanism for urine catheterisation with simulated urine. > Must have central and peripheral pulses that link with software. > Must have a mechanism to insert a needle into its chest for pneumothorax management. > The upper skin of the manikin must be ready for conversion of Sonography if so required. > The manikin must have ports where bleeding can be simulated. > The teeth of the manikin must be removable to simulated denture airway management during advanced airway techniques. > The manikin must be able to provide accurate vital signs which include ECG monitoring, Saturation, EtCO2 monitoring, Defibrillation techniques (use of both pads 		

	<p>and paddles).</p> <ul style="list-style-type: none"> > The manikin must be able to accommodate both basic and advanced airway procedures (invasive) as well as nasal intubation. > The manikin must include both the hardware and software licensing required to make the manikin function fully. > The company must be able to provide us (the college) with maintenance and service assistance whenever needed. > The chest and arm skins must be removable for cleaning and maintenance procedures. 		
<p>ITEM 2 : Standard Birthing Simulator</p>	<p>The birthing simulator should be made of high-quality silicone and plastic to reliably withstand the training requirements. The skin or silicone must be able to stretch, without tearing, to realistically simulate new-born delivery. The birthing simulator must be anatomically correct and be able to accommodate a module that simulates post-partum haemorrhage. The upper legs of this simulator must have pads on both legs to simulate the injection of medications required during labour. The abdominal skin must be removable and held in place by strong clips/buttons. The leg section on this trainer must be able to move, realistically, to the positions simulated during labour. The leg sections must have the option to install the full leg segments if so required. The trainer must include a cervix opening for realistic birthing processes, which must be removable. The birthing trunk of this trainer must be anatomically correct to allow for realistic simulated birthing sessions to occur. The trainer must include a new-born sized baby which must be fully articulating on arms and legs. The new-born must have anatomically correct facial features and include an umbilicus. The trainer must come standard with the following items:</p> <ul style="list-style-type: none"> > Straps to hold the trainer in place during training. > Lubricant, with a gel-like consistency, to allow for smooth passing of the new-born through all areas requiring lubrication. > A placenta with umbilical cord that can be attached and detach to the new-born. > A removable and stretchable cervix. > Must be able to complete urine catheterization on this trainer. 		
<p>ITEM 3 : Post Partum Haemorrhage Adapter for Standard Birthing Simulator</p>	<p>The post partum haemorrhage (PPH) simulator must be compatible with the birthing simulator/trainer as discussed above. The PPH trainer must be made of high quality silicone/plastic to withstand high usage during training. The PPH trainer must be able to fit onto the simulator and must be able to lock into place using a locking mechanism to prevent movement during training. The PPH trainer must realistically be able to bleed and have a mechanism to simulate medical procedures to stop the bleeding. The PPH trainer must include the following:</p> <ul style="list-style-type: none"> > All tubing required to simulate bleeding. 		

	> A container and artificial blood to prepare the trainer for bleeding		
ITEM 4: Urine Catheterization training/simulation set	<p>The urine catheterization simulator/trainer must be made from a high quality silicone/plastic to withstand high demand training. The trainer must be anatomically correct to simulate urine catheterization in both male and female patients. The genitals of this trainer must be removable to allow for easy maintenance and cleaning. One "pelvis" or trainer must have the option of using both male and female genitalia, interchangeably. The urine catheterization trainer must include the following:</p> <ul style="list-style-type: none"> > Removable male and female genitalia. > Simulated structures of a human bladder with the option to expel urine if so required. > Be able to adjust in simulating various difficulties in catheter insertion. > Include a container which holds the simulated urine/water. > Include all the tubing required to simulate urine withdrawal. > If possible, include a stand to hold the container with simulated urine. 		
ITEM 5: Chest drain and Needle decompression trainer	<p>The chest drain and needle decompression simulator/trainer must be made from a high-quality silicone/plastic to withstand high demand training. The silicone construction must be removable for ease of cleaning, repair and preparation for training. The trainer must be anatomically correct to simulate the correct landmarks required for training purposes. The trainer must include needle insertion sites on top and on the sides of the trainer to simulate various procedures. The areas/modules used for insertion of needles must be easily replaceable and durable enough to withstand a large amount training requirement. The modules where needles are inserted into, must include a mechanism to inflate them to realistically simulate the various medical interventions.</p>		
ITEM 6: Training AED	<p>The training AED must be clearly marked for training. All components for this AED must be enclosed in a durable plastic case to prevent damage.
