South African National Parks (SANParks) has adopted Vision2040, a comprehensive 15-year strategic framework that will guide its transformation journey through to the year 2040. Vision2040 is designed to position SANParks as a leader in ecological sustainability, inclusive socio-economic development, and nature-based tourism. It aims to transform national parks into dynamic spaces that empower communities, foster partnerships, and promote conservation-led growth.

A key pillar of Vision2040 is the advancement of Mega-Living Landscapes—large, interconnected ecological systems that support biodiversity, climate resilience, and sustainable livelihoods through integrated land-use planning and collaborative stewardship.

To successfully implement Vision2040, SANParks recognises the need for deep and sustained organisational change. This includes not only technical and operational shifts but also significant cultural, institutional, and behavioural transformation across the organisation. To date, no formal change management process has been undertaken to support this transformation. A comprehensive, organisation-wide change management programme now needs to be developed and rolled out to ensure that all staff understand, support, and actively contribute to the Vision2040 long-term strategy.

### **The key objectives of the assignment include:**

- Assess the SANParks employees' readiness for change.
- Identify and address cultural, behavioural, and systemic barriers to change.
- Facilitate employee engagement to ensure alignment and support for Vision2040.
- Design targeted change interventions, training, and communication strategies.
- Provide ongoing monitoring and evaluation of change management efforts.

## CONTRACT PERIOD

## SPECIFICATIONS/SCOPE OF WORK

- **Conduct a comprehensive situational analysis** to determine SANParks' organisational readiness to implement Vision2040. This includes assessing how well staff across all levels know, understand, and support Vision 2040, and identify any concerns or areas of resistance. The analysis should include stakeholder mapping and utilise appropriate tools such as surveys, interviews, and focus groups. Undertake the situational analysis across all 21 National Parks ensuring that the unique operational realities of each park, geographic location, and cultural contexts (language preferences, attitudes toward organisational hierarchy, etc.) are taken into account.
- **Develop a tailored change management model** that is tailored to SANParks' organisational culture, operational realities and geographic footprint, and communication methods. The model should be grounded in recognised change management frameworks but adapted to SANParks' specific context. It must be practical, implementable, and aligned with the goals of Vision 2040.
- **Design and implement a comprehensive change management plan** that translates the model into actionable steps. The plan should include clear milestones, timelines, roles and responsibilities, and mechanisms for feedback and adaptation.
- **Support leadership and staff** to drive organisational change programme that focuses on individuals, teams and organisational system. This includes the transfer of skills through training and support structure and the provision of toolkits and templates for ongoing change facilitation.
