4. EVALUATION PROCESS

Bidders must submit all required documents indicated hereunder with the bid documents at the closing, date and time of the bid. During this evaluation phase, bidder's responses will be evaluated based on the documents submitted under mandatory requirements. Any bid that does not meet these requirements will be disqualified, and will be considered as non-responsive

The received bid proposals will be evaluated in one evaluation stage to arrive to the final phase of bid award, and the phases will be as follows:

STAGE 1 – COMPLIANCE SCREENING / ADMINISTRATIVE COMPLIANCE

In this phase all bids received will be verified for compliance and completeness of the submitted proposal per the below set of requirements. **Bidders who fail to comply with the below requirements will be eliminated and bidders who comply will be deemed responsive and qualify for the bid.**

The following forms must be completed and signed in full as per the requirement of the bid, failure to provide, complete and sign the documents listed below will lead to disqualification:

(failure to do so will lead to disqualification)

Amatola Water invites quotations from suitably qualified and experienced service providers for the **PANEL FOR PROVISION OF WATER TRUCKS (WATER CARTING) TO SUPPLY WATER IN VARIOUS MUNICIPALITIES WITHIN THE PROVINCE OF EASTERN CAPE ON ADHOC BASIS FOR THE PERIOD OF THREE YEARS.**

1. BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

2. SCOPE OF WORK

2.1 Scope of work

The Scope of work for this project is summarised as follows:

- Provision of portable water to the communities, schools, Municipalities and other government institutions through water trucks within the Eastern Cape Province;
 - The Service Provider to cart portable water on as and when basis as instructed by an Official that will be confirmed by Amatola Water;
 - Logsheet to be filled properly by Service Provider, signed and stamped by an Official after each and every load, see the attached logsheet on **Appendix A**;
 - The Service Provider to submit weekly Progress Report to Amatola Water;
 - The Service Provider to cart portable water only from registered water source confirmed by an Official;
 - The Service Provider to ensure that the water truck, associated pipework and equipment is disinfected and suitable to transport portable water prior use;
 - The total number of loads to be delivered will be limited based on the amount of the Purchase Order issued by Amatola Water to the Service Provider. It is the responsibility of the Service Provider to ensure that the total number of loads delivered with inclusive of the kilometers travelled do not exceed the value of the Purchase Order.

2.2 Specification

Required specifications and requirements for this project are as detailed below:

- The capacity of water truck must be able to carry and delivery minimum of 10 000 liters per load of portable water. **The Service Provider to provide the proof of water truck registration papers.**
- The service provider to ensure his/her water truck is roadworthy before carting water;
- The Service Provider to ensure that the water truck comply with any local regulations and standards set by South African authorities:
- The Service Provider of the water truck that used to transport drinking water must ensure that tank/s, associated pipework and equipment used for loading or unloading of portable water have not been used previously for transporting any noxious, toxic or hazardous matter, non-food liquids or human or animal wastes.

Note:

- **PROOF OF LOCALITY:** Lease Agreement / Municipal Bill Or Letter of Residence from Ward Councilor
- **PROOF OF OWNERSHIP** - registered under the bidding company/owner or a signed Lease Agreement.
- **REIMBURSEMENT FOR KILOMETERS:** The service provider will only be reimbursed for water carted from water source to a delivery point and return to the source.
