Prequalification: Only tenderers who meet the following prequalification criteria may respond:

- Original BBBEE Certificate or a certified copy thereof (Joint venture, consortium, or trust must submit a consolidated certificate). Failure to submit this certificate will lead to not getting points for BBBEE Level;

- A Company Profile with contactable references;
- Municipal Statement not older than three (3) months or Lease agreement if renting premises, accompanied by an affidavit.
- A minimum of three Appointment letters, Practical Completion or Final Completion Certificate, and reference letters for similar work. (Completion certificate and Reference letters to be relative to the project at which the Appointment letter is issued)
- The proposed project Methodology Plan
- Tenderers with a minimum CIDB Grade 3 CE/GB or higher
