1. INTRODUCTION TO THE SIU

The SIU is an independent statutory body established by proclamation R.118 of 31 July 2001, issued in terms of the Special Investigating Units and Special Tribunals Act No. 74 of 1996 as amended ("*the SIU Act*"). The purpose of the SIU is to investigate serious malpractices, maladministration, and corruption in connection with the administration of State Institutions, state assets and public money as well as any conduct, which may seriously harm the interest of the public. Furthermore, the purpose of the SIU is to institute and conduct civil proceedings in any court of law or a Special Tribunal in its own name or on behalf of State Institutions.

2. PROJECT BACKGROUND

The Special Investigating Unit (SIU) requested proposals from suitably qualified and experienced service providers to develop a Data Warehouse with Data Analytics functionality to meet the data and information storage, processing, management, and governance needs of the Special Investigating Unit (SIU).

Upon the closing date of the tender, the SIU received 24 proposals.

The Bid Evaluation Committee (BEC) has completed its evaluation of proposals and made a recommendation for award.

SIU Internal Audit has conducted a quality assurance review but, due to limited IT expertise, has recommended that an **independent external service provider** be appointed to provide a professional opinion on the technical adequacy of the recommended award (one bid). It is critical that the service provider has expertise in both the ICT and SCM fields or be able to subcontract one or the other element, as the opinion to be provided has both ICT and SCM specifics related to it.

Attached is the Bid document with Terms of Reference that was advertised on the market.

3. The RFQ will be evaluated in three (03) stages.

- **The first stage of evaluation:** Bidders will be evaluated on administrative requirements.
- **Second stage of evaluation:** Bidders will be evaluated on functionality. Minimum score on functionality is 70 points.
- **Third stage of evaluation:** Price and BBBEE and specific goals.

7. SCOPE OF WORK (TERMS OF REFERENCE)

Appointment of a Service Provider to Render Independent Technical and Quality Assurance Services on the Recommended Award for the Development of a Data Warehouse with Data Analytics Functionality for the Special Investigating Unit (SIU).

- To obtain an **independent, expert technical assurance** on the recommended award (one bid).
- To provide SIU management and oversight structures with **confidence in the award decision**.

The appointed service provider will:

1. Review of the Recommended Award

- Examine the proposal recommended by the BEC.
- Assess whether the reference letters or supporting document submitted by the service provider meet the requirement set out on the evaluation criteria and the scope of work as advertised on the bid document.
- Validate compliance with SCM prescripts, Regulation that govern the SCM department.

2. Independent Quality Assurance

- Evaluate reference letters and other supporting document to ensure compliance with the criteria and bid document that was published.
- Assess vendor capacity, skills, and track record in delivering similar solutions.

3. Opinion & Assurance

- Provide an independent opinion on whether the recommended bidder meets the requirements outlined in the advertised bid document.
- Provide an independent opinion on whether the recommended award is technically sound and capable of delivering the intended outcomes.

4. Deliverables

- Independent Technical Assurance Report on the recommended award.
- Risk & Gap Analysis with mitigation recommendations.
- Final Assurance Opinion confirming suitability or advising conditions for award.

5. Expertise Required

- Proven experience in Data Warehouse and Analytics solution.
- Strong background in IT quality assurance, data governance, and information security.

- Independence from bidders to ensure objectivity.

6. Duration

- The assignment is short-term, to be completed within 3–4 weeks after appointment, ensuring minimal delay in award finalization.

7. Compliance & Confidentiality

8. BID CONDITIONS

- 7.1. This project cannot exceed the threshold of R1 000 000.00.

- 7.3. Bidders must be prepared to sign a confidentiality agreement with the SIU.
- 7.4. The recommended bidder will be requested to provide the CVs of the specific team members that will be involved in the project.
- 7.5. The minimum qualification required from each team member is an NQF level 7 (degree).

9. CONTRACT PERIOD

Three to four weeks project.

TERMS AND CONDITIONS OF THE CONTRACT

9.1. AWARD CRITERIA

Bid will only be awarded to the bidder who passes SIU's Internal Integrity Unit screening and/or State Security Agency vetting; failure to pass could result in SIU not awarding the bid to a bidder irrespective of the points scored after the final evaluation.

SIU promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organization and individuals who will be providing the service and the organisational capacity supporting the project team.

SIU is committed to achieving the government's transformation objectives in terms of the Preferential Procurement Policy Framework Act (PPPFA), Procurement Regulation 2022. The value of this bid is estimated not to exceed R 1 000 000.00 (all applicable taxes included) and therefore the 80/20 system shall be applicable. (This is by no means the budget of the project but the process threshold as per PPPFA) The procedure for the evaluation of responsive bids is Price, and Preference method.

B-BBEE STATUS LEVELS

A bidder and/or service provider will be used interchangeably across the bid document.

Responsive bids are those bids that meet the eligibility/mandatory/administrative criteria as set out on the bid document.

The preference points evaluation of the responsive bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor.
