Any clarification required by a bidder regarding the meaning or interpretation of the Terms of Reference, or any other aspect concerning the bid, is to be requested **from the date of bid publication** (30 June 2023) in writing by e-mail from scm@nersa.org.za not later than 12:00 on the **18 July 2023**. No clarification will be attended to after this closing time.

A reply will be forwarded on **19 July 2023**. The bid reference number should be mentioned in all correspondence. Telephonic requests for clarification will not be accepted. If appropriate, the clarifying information will be made available to all bidders by e-mail only.

3 SUBMITTING BIDS

One (1) original of the bid document plus one (1) **memory stick** that contains the duplicate of the original submission to be handed in / delivered to: The Procurement Manager, NERSA, Kulawula House, 526 Madiba (Vermeulen) Street, Arcadia, Pretoria.

The original version of the bid must be submitted with one (1) memory stick. Failure to submit the original plus one (1) memory stick and to include all attachments in the memory stick will result in automatic disqualification. Bidder(s) will also be disqualified for submitting a blank memory stick. The original bid document must be fully completed and/or signed in ink and thereafter duplicate the original in the memory stick with all its attachments.

International bidders do not have to be a locally registered entity in South Africa in order to bid. See QUESTIONNAIRE TO BIDDING FOREIGN SUPPLIERS on the Invitation to Bid Form. Therefore, if responses to all questionnaire were no, then it's not a requirement to register for a tax compliance status system pin code from the South African Revenue Service (SARS).

NB: Bidder(s) will be disqualified for failing to submit the original plus one (1) memory stick. Failure to include all attachments in the memory stick will result in automatic disqualification. Bidder(s) will also be disqualified for submitting a blank memory stick.

5 LATE BIDS

Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be locked at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

The official Telkom time (Dial 1026) will be used to verify the exact closing time.

Bids sent to NERSA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NERSA premises (in tender box in reception area or if too big for the tender box, over the counter in the reception area). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

7 NEGOTIATION AND CONTRACTING

- 7.1 NERSA has the right to enter into negotiation with one or more bidders regarding any terms and conditions, including price(s), of a proposed contract.
- 7.2 NERSA shall not be obliged to accept the lowest of any quotation, offer or proposal.
- 7.3 A contract will only be deemed to be concluded when reduced to writing in a formal contract and Service Level Agreement signed by the designated responsible person of both parties. The designated responsible person of NERSA is the Chief Executive Officer (CEO) or his/her written authorised delegate.
- 7.4 Under no circumstances will negotiation with any bidders constitute an award or promise / undertaking to award the contract.

8 ACCESS TO INFORMATION

All bidders will be informed of the status of their bid once the procurement process has been completed.

Requests for information regarding the bid process will be dealt with in line with the NERSA procurement policy and relevant legislation.

9 REASONS FOR REJECTION

- 9.1 NERSA shall reject a proposal for the award of a contract if the recommended bidder has committed a proven corrupt or fraudulent act in competing for the particular contract.
- 9.2 NERSA may disregard the bid of any bidder if that bidder, or any of its directors:
- 9.3 Have abused the SCM system of NERSA.
- 9.4 Have committed proven fraud or any other improper conduct in relation to such system.
- 9.5 Have failed to perform on any previous contract and the proof exists.
- 9.6 Such actions shall be communicated to the National Treasury.

10 PAYMENTS

- 10.1 NERSA will pay the contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by NERSA to the contractor.
- 10.2 The contractor shall from time to time during the currency of the contract, invoice NERSA for the services rendered.

- 10.3 The invoice must be accompanied by supporting source document(s) containing detailed information, as NERSA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the contractor.
- 10.4 No payment will be made to the contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NERSA.
- 10.5 Payment shall be made by bank transfer into the Contractor's bank account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).

11 CANCELLATION OF PROCUREMENT PROCESS

This procurement process can be postponed or cancelled at any stage provided that such cancellation or postponement takes place prior to entering into a contract with a specific service provider to which the bid relates.

BIDDERS MUST TAKE NOTE OF THE EVALUATION PROCESS THAT WILL BE FOLLOWED**1 EVALUATION PROCESS****1.1 COMPLIANCE WITH MINIMUM REQUIREMENTS CRITERIA**

All bids duly lodged as specified in this Request for Bid will be examined to determine compliance with bidding requirements and conditions. Bids with deviations from the requirements / conditions, will be eliminated from further consideration.

1.2 SELECTION CRITERIA, PRICE AND PREFERENCE POINTS

- 1.2.1 All remaining bids as per paragraph 1.1.1 will be evaluated as follows:
- 1.2.2 Bids will be evaluated first on selection criteria and then in accordance with the 80/20 reference points system prescribed in Preferential Procurement Regulations.
- 1.2.3 The First stage, bids will be evaluated on selection criteria, of which (100 points) shall be awarded on selection criteria evaluation.
- 1.2.4 Bids will be considered further if it achieves the minimum prescribed qualifying score for selection criteria (60.00 points out of 100). Bids that failed to achieve the minimum qualifying score on selection criteria will be disqualified for further evaluation.
- 1.2.5 The Second stage, bids will be evaluated in terms of the 80/20 preference point systems. Only bids that achieve the minimum qualifying score/percentage on selection criteria will be evaluated in accordance with the 80/20 preference point system.

1.3 DETERMINATION OF PERCENTAGE FOR SELECTION CRITERIA

- 1.3.1 The evaluation criteria and weights on selection criteria as indicated in the table in paragraph 2, will apply.
- 1.3.2 The percentage scored on selection criteria should be calculated as follows:
- 1.3.3 Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score. The following formula should then be used to convert the total score to a percentage on selection criteria:

where

Ps = percentage scored on selection criteria /proposal under consideration

So = total score of bid/proposal under consideration

Ms = maximum possible score

Ap = percentage allocated on selection criteria

- 1.3.4 The percentages of each panel member shall be added together and divided by the number of panel members to establish the average percentage obtained by each individual bidder on selection criteria evaluation.

1.4 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

- 1.4.1 Bids that score less than **60%** of the marks available on selection criteria evaluation will be eliminated from further consideration.
- 1.4.2 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 1.4.3 The percentage scored for price shall be calculated as follows:

A maximum of 80 points is allocated for price on the following basis:

80/20

1.6 COMBINING PRICE AND SPECIFIC GOALS

- 1.6.1 The points for specific goals will now be added to the price.
- 1.6.2 Only the bid with the highest number of points scored may be selected for award.

SECTION A Part 2: Evaluation Process/Criteria

- 1.6.3 The Bid Adjudication Committee will consider the recommendations and make the final award. The successful bidder will usually be the bidder scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.

1.7 PRESENTATIONS (optional)

- 1.7.1 NERSA reserves the right to invite bidders for presentations before the award of the bid.
- 1.7.2 NERSA may decide to have compulsory presentations made either by all bidders who have obtained at least **60%** of the marks on selection criteria evaluation, or by the bidders ranked first, to third once the selection criteria, price and preference marks have been combined.
- 1.7.3 Presentations shall only affect the marks awarded on selection criteria evaluation. If NERSA wishes to use presentations to discriminate between bidders, the evaluation criteria to be affected shall be determined in advance and due allowance made in the mark scheme and indicated in paragraph 1.2 above.
- 1.7.4 If the date of the presentation meeting is not indicated in the bid document, at least three days' notice will be given to bidders required to attend a presentation as well as the detail of the venue for the presentation.
- 1.7.5 Presentations will be made to the full Bid Evaluation Committee.
- 1.7.6 Points determined by the presentation will be awarded to each bidder by each member of the Bid Evaluation Committee and then an average calculated.
- 1.7.7 Under no circumstances will a presentation by any bidder constitute an award or promise / undertaking to award the contract.

1.8 ADJUDICATION OF BID

- 1.8.1 The Bid Adjudication Committee will consider the recommendations and make the final award. The successful bidder will usually be the bidder scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.

2 EVALUATION CRITERIA

Service providers will be evaluated in accordance with the Supply Chain Management Policies as well as the Preferential Procurement Policy Framework Act, 2000 (Act No.5 of 2000), and Preferential Procurement Regulations of 2022.

2.1 Phase 1: Compliance with minimum requirements

Service providers will be examined to determine compliance with the bid document terms and conditions. Bidders who fail to comply with the minimum requirements will be eliminated from further evaluation.

2.2 Phase 2: Selection Criteria

All proposals will be evaluated by the evaluation panel independently in terms of the selection criteria which will be made up of 100 points as follows:

THE APPOINTMENT OF A REPUTABLE SERVICE PROVIDER TO PARTNER WITH FOR THE ADOPTION OF CLOUD COMPUTING SERVICES FOR A PERIOD OF THREE (3) YEARS.

1. PURPOSE

NERSA seeks to appoint a reputable service provider to partner with for the adoption of Microsoft Cloud Computing services for a period of three (3) years.

2. ROLE OF NERSA

NERSA is the regulatory authority established in terms of the National Energy Regulator Act, 2004 (Act No. 40 of 2004) with the mandate to undertake the functions of the Gas Regulator as set out in the Gas Act, (Act No. 48 of 2001), the Petroleum Pipelines Regulator as set out in the Petroleum Pipelines Act, 2003 (Act No. 60 of 2003) and the Electricity Regulator as set out in the Electricity Regulation Act, 2006 (Act No. 4 of 2006).

NERSA's Vision is:

To be a world-class leader in energy regulation

NERSA's Mission is:

To regulate the energy industry in accordance with government law and, policies, standards and International best practices in support of sustainable development

The functions of NERSA are as outlined in terms of section 4 of the Electricity Regulation Act, 2006 (Act no.4 of 2006) Section 4 of the Petroleum Pipelines Act, 2003 (Act No. 60 of 2003) and section 4 of the Gas Act, 2001 (Act No.48 of 2001).

3. BACKGROUND AND CONTEXT

A surge in remote working has put the focus on Cloud Computing (CC) to support work-from-home requirements, maintain business continuity and build business resilience.

In 2020 an International Data Group Incorporated (IDG) survey reported that 81% respondents are already using computing infrastructure or having applications in the cloud compared to 73% in 2018. Another 12% plan to adopt cloud-based applications in the next 12 months and 6% plan to do so in the next 1 to 3 years. Cloud adoption has reached more than two-thirds in every industry, though adoption is higher in education (88%), manufacturing (87%), and healthcare (86%), than in financial services (75%) and government/non-profit (71%).

"By 2022, 75% of organizations that implemented work-from-home policies for their workforce during COVID-19 will retain the remote working options for their employees," said Ed Anderson, Distinguished VP Analyst, during his presentation at virtual Gartner IT Symposium/Xpo® 2020. "Cloud adoption will continue to accelerate as key workloads are needed to support remote workers and maintain data center operations."

SECTION A Part 4: Terms of Reference

In February 2022 the Department of Public Service and Administration (DPSA) published the “DETERMINATION AND DIRECTIVE ON THE USAGE OF CLOUD COMPUTING SERVICE IN THE PUBLIC SERVICE” document (Annexure A). The purpose of this document is stated as ‘The purpose of this Determination and Directive is to provide clear guidance on the adoption and use of cloud computing services in the public service’.

The COVID-19 disruption, forced NERSA to also implement Cloud Computing (CC). In June 2020 NERSA implemented Ms Teams to facilitate virtual meetings. Teams is a collaboration platform that unifies chat, voice, video and file sharing. It’s designed to be used by local, remote and distributed work groups. Irrespective the rich features within Teams at NERSA the application is only used for virtual meetings.

In a post-pandemic world, there will be opportunity to move key workloads to the cloud for the benefits it offers today and to prepare for the next unforeseen disruption. Organisations of all types should sensibly evaluate which CC service model; private, public, community or hybrid suites their line of business. Which Cloud orchestration; software as a service (SaaS), infrastructure as a service (IaaS) or platform as a service (PaaS) best suites which business process. Which workloads can be moved to the cloud environment given aspects of data confidentiality and need for security.

4. SCOPE OF WORK

NERSA is looking for a service provider to partner with on its Microsoft Cloud Computing migration journey. The prospective partner must show a pragmatic approach to the adoption of Microsoft Cloud Computing given the sensitivity of data and information NERSA work with.

Currently the National Energy Regulator of South Africa (NERSA) uses Microsoft suite and other departmental applications. The products from the Microsoft product suite in the organisation;

- Microsoft Office
- Microsoft Windows Servers
- Microsoft Active directory
- Microsoft Exchange server
- Hyper-V
- Various applications

At a minimum, the following services are required:

- Comprehensive assessment
- Migration Roadmap
- Training of current staff
- Maintenance and support

5. DELIVERABLES

5.1 Comprehensive assessment

Assessment of the current ICT environment in order to understand and prioritise the solutions that are suitable to migrate cloud. This assessment will include the infrastructure and applications hosted currently on premise.

The outcome of this assessment exercise will be a comprehensive roadmap to migrate solutions to the cloud.

5.2 Migration Roadmap

Will focus on the first priority as determined by the assessment phase. The first priority will potentially include Microsoft 365 cloud services but not limited to implementation of and integration of AD directory in cloud, migrations Exchange server to Exchange Online, multi factor authentication, Microsoft Intune and other crucial Microsoft solutions.

5.3 Training and development/Skills transfer

The bidders must be in a position to help NERSA identify a career path for current ICT staff to support the Microsoft Cloud environment. The bidder must ensure skills transfer during the contract period.

5.4 Maintenance and Support

The bidders must have the capacity to provide NERSA with the maintenance and support during the contract period.

5.5 General

NERSA request bidders to submit proposals for the setup of Azure tenant, migration, design, support, maintenance and training inclusive, but not limited to, the system below;


