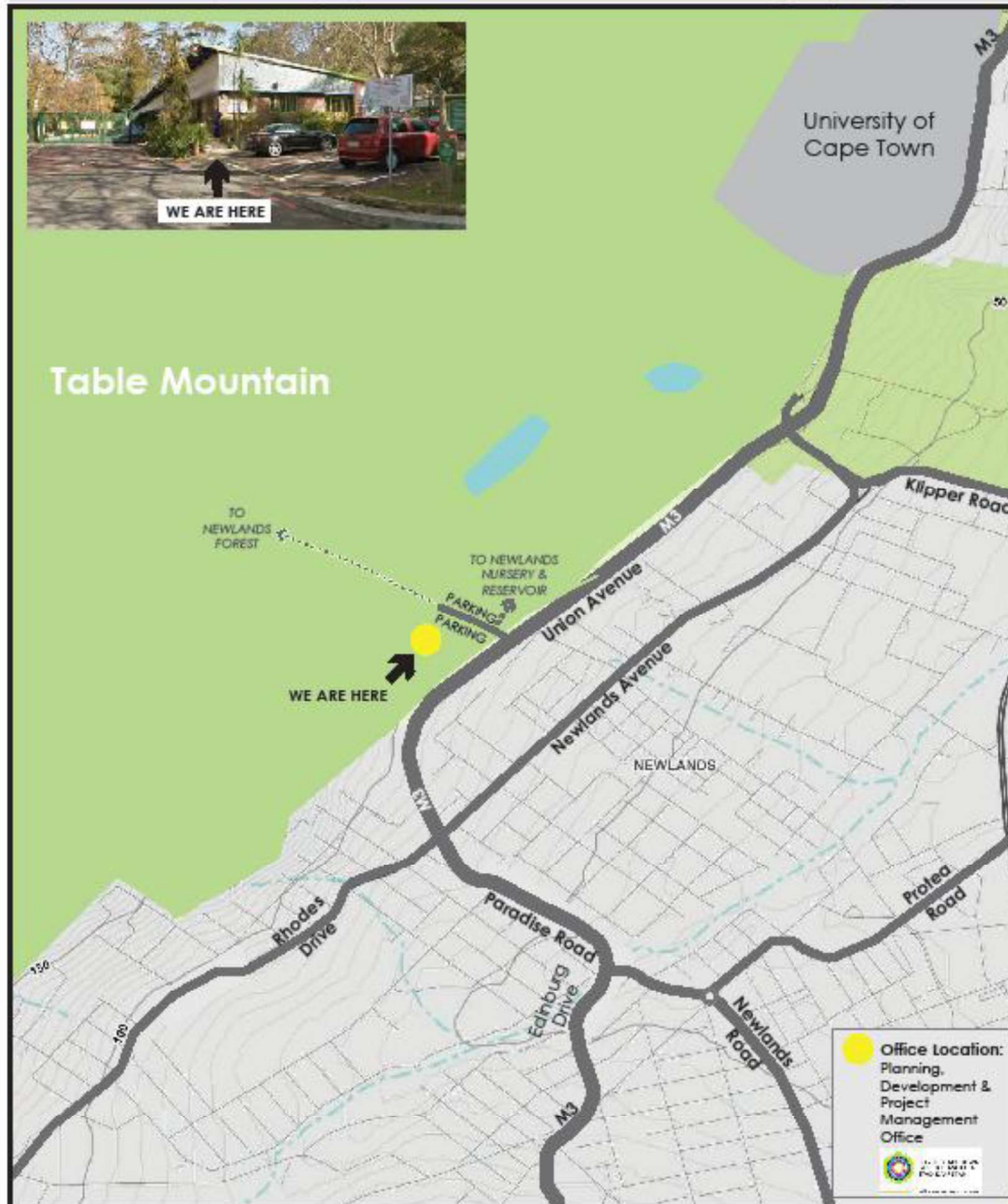
Coming from the Somerset West via N2:
