1. THE PURPOSE

This tender aims to appoint a service provider for the supply and delivery of disposable body bags for all the Gauteng Forensic Pathology Service facilities for three years.

2. BACKGROUND

Forensic Pathology Service's primary objective is to render a medico-legal investigation of unnatural deaths. Under the National Health Act (Act 61 of 2003) requirements, the Gauteng Department of Health took over the responsibility for providing the Forensic Medical Service (FMS) with effect from 1 April 2006.

There are 11 Forensic Pathology Service laboratories in Gauteng that work with other stakeholders when unnatural deaths are reported. When called out to scenes, one of the crucial items that Forensic Officers carry with them is body bags used to collect bodies to preserve evidence. Body bags are used when issuing out bodies to respective families. According to the standard operating procedures, at least two body bags should be used per body. However, the Forensic Pathology Service facilities process plus minus twenty-two thousand (22 000) bodies on average per annum and are likely to use three body bags per body which will amount to sixty-six thousand (66 000) per annum, which amount to hundred and ninety-eight thousand (198 000) per cycle of three years.

3. LEGISLATIVE AND REGULATORY FRAMEWORK

3.1 The General Conditions of Contract (GCC):

5. SPECIFICATION FOR DISPOSABLE BODY BAGS

5.1 SCOPE

This specification covers the requirements for disposable body bag material, cut and make.

5.2 **REQUIREMENTS**

NOTE - Unless inconsistent with the text, all measurements are nominal. WORKMANSHIP - Disposable body bags shall be manufactured with quality workmanship.



5.3 MATERIALS

The manufacturer shall use the following materials:

5.3.1 Plastic

The body bag shall be made with recycled, non-biodegradable plastic with a thickness of not less than 150 microns.

The service provider (Bidder) shall provide a confirmation letter from the plastic manufacturer that specifies the material type, qualities and thickness of not less than 150 microns.

5.3.2 Colour

The colour of the plastic used for the body bag shall be a beige or ivory colour as for recycled plastic.

Slide fasteners, described below, shall be in black.

Wording to be applied with screen-printing on the body bag (described below) shall be in red.

5.3.3 Slide-fastener (Zip)

The slide-fastener shall be a genuine YKK ZIPLON chain or equivalent (type 5RCF plastic/nylon zipper chain) with two DFLLK sliders to accommodate a lockable device. The cord, slide fasteners, tape and elements (teeth) shall be black.

The service provider (Bidder) shall provide a confirmation letter from the slide-fastener manufacturer that specifies the zipper description, material and qualities.

5.3.4 Sewing Thread

Size 25 poly-cotton core-spun thread shall be used to sew the Zip onto the plastic in line with the specified requirements for cotton core-spun sewing threads provided in SANS 1362:2018. Also see SANS 10101:2008 (2014-05-09) – Standard nomenclature for stitches, seams and stitchings.

5.4 APPEARANCE

5.4.1 Size

The body bags shall consist of only one size 2.4m in length and 1m wide, referred to as size X-Large.



5.4.2 Style

The body bag shall be the length and width of the specified size, inside-facing with a U-shaped zip with two lockable sliders as shown in "ANNEXURE A - APPEARANCE".

The upper part of the body bag (zip-side) shall contain markings in red, as described below.

5.5 MANUFACTURING

5.5.1 Heat-bonding of plastic

Heat-bonding of the plastic material to form a bag shall provide a secure and leak-proof body bag, provided the zip is on top.

5.5.2 Zip Placement and Attachment

The zip will be sewn 10 cm from the edges of the bottom and sides of the body bag in a U-shape pattern as shown in "ANNEXURE A - APPEARANCE".

When sewn into the plastic and zip tape to attach both parts, the sewing thread shall have a breaking strength of at least 12N (Newton) and be compatible in terms of linear density with the material with which it is used.

SANS 10101:2002 (2014-05-09) (Standard nomenclature for stitches, seams, and stitchings) shall be a guideline.

5.5.3 Markings

The body bag shall be marked utilising screen-printing with a suitable red adhesive screen-printing paint with the wording and layout as follow:

The screen printing will be applied on the top side containing the zip across the length centred in the middle of the body bag, with the closed edge without a zip above and the long edge of the zip-side at the bottom of the wording. The font type and size of the wording in bold with a line spacing of 1.15 shall be as follow:

The total screen-printed area with wording shall be approximately 253mm high and 242mm wide.

Screen printing should not peel off after time while in storage or use within the immediate mortuary environment. To improve the bonding of the screen-printing paint to the plastic material, the area of plastic where the screen-printing will be applied can be lightly sanded with fine-grain sandpaper.

5.6. GENERAL

5.6.1 Unit of Measure

The unit of measure is each, representing one body bag.

5.6.2 Packaging

Body bags shall be delivered in bales of fifty (50) body bags, contained in a suitable bag that displays the following information on the outside of the bag:

5.6.3 Lead-time for delivery

The expected lead time for delivery is seven (7) days.



5.6.4 Duration of the contract

The contract lasts three (3) years, ensuring the product meets the requirements.

5.6.5 Testing of samples to verify compliance with specifications

Random samples will be drawn from each delivery to verify compliance with the specification in terms of the following:

- The thickness of plastic to be not less than 150 microns;
- Visual inspection of workmanship, inclusive of heat-bonding, attachment of zips, zip type and colour, quality and functionality;
- Visual inspection of the quality of the screen-printed wording on the body bag, including print colour, font type, size, line spacing, and adhesiveness of the paint to the body bag.

Body bags found to be defective or that become defective during storage due to poor workmanship or quality, e.g. paint peeling off or deterioration of the plastic, shall be collected by the service provider at the service provider's expense. The defective body bags will be inspected in the presence of the service provider to verify defects. Defective body bags must be replaced within the lead period with body bags that meet the specifications and quality requirements.

5.6.6 Estimated demand


The estimated number of disposable body bags that will be ordered per annum is 66 000 (sixty-six thousand).

6. EVALUATION METHODOLOGY

The evaluation of the bids will be done under the requirements of the Preferential Procurement Policy Framework Act (Act 5 of 2000) and the Preferential Procurement Regulations, 2022 in two stages:

Stage 1A: Mandatory Administrative Responsiveness

Stage 1B: Sample Evaluation

Stage 2: Price and Preference Points Evaluation

The 80/20 preference point system, which applies to bids with a Rand value equal to or above R2000 and up to a Rand value of R50 million (with all applicable taxes included), shall be applied, where a maximum of 80 points will be allocated for price and maximum of 20 for specific goals in terms of the requirements of the Preferential Procurement Policy Framework Act (Act 5 of 2000), the Preferential Procurement Regulations of 2022 and the Gauteng Department of Health Preferential Procurement Policy of 2022.



STAGE 1A: MANDATORY ADMINISTRATIVE COMPLIANCE

All bids received will be subjected to mandatory administrative compliance per the requirements below. This phase is not scored, and any bidder who fails to comply with the mandatory criteria will be disqualified.

1. A letter of confirmation from the plastic manufacturer:

- 1.1 The bidder must provide an original or a certified copy of a letter from the plastic manufacturer confirming the period of arrangement with the bidder to supply plastic for the manufacturing of body bags;
- 1.2 Such a letter must also confirm and specify the material type, qualities and thickness of not less than 150 microns.
- 1.3 Such a letter should be current and not older than the tender advert date.

2. A letter of confirmation from the slide-fastener manufacturer that specifies the zipper description, material and qualities:

- 2.1 The bidder must provide an original or a certified copy of a letter from the slide-faster manufacturer confirming the period of the arrangement with the bidder to supply slide fasteners for the manufacturing of body bags;
- 2.2 Such a letter must also confirm and specify the zipper description, material and quality (The slide-fastener used shall be a genuine YKK ZIPLON chain or equivalent).
- 2.3 Such a letter should be current and not older than the tender advert date.

3. List of Samples RFP 10.1:

Bidder to complete RFP 10.1 for sample evaluation for the body bag, which is bidded for.

- 4. Bidder must submit fully completed and signed SBD forms.

If a bidder does not meet all the above requirements, the bid will be disqualified and not considered for further evaluation.



STAGE 1B: SAMPLE EVALUATION

Only bidders who complied with the Mandatory Administrative Compliance Stage 1B will be considered for the sample evaluation. All such bids received will be subjected to a sample evaluation. Bidders must complete RFP 10.1: Supply of Samples and attach it to the bid document.

Submission of Samples

Bidders must submit at least one new sample still sealed and unopened in the original packaging for the sample evaluation.

The Department reserves the right to request that the shortlisted compliant bidders provide at least one sample for further testing at the Forensic Medical Service.

No Samples must be sent to the Gauteng Department of Health but must be delivered to the following address:

Bidders' sample boxes must be marked using the format, e.g., 1 of 1. This is imperative to ensure the total number of sample boxes delivered is accounted.

Samples must comply with the specification and be an accurate representation of the products which will be supplied.

All samples for awarded items will be retained for the contract period.

Pre-award sample compliance

The items must comply with the specification and standards stated in the bid document. Samples of products offered must be submitted for evaluation to determine compliance with the specification and standards during the evaluation phase.

The Bidder will be disqualified for a bid that does not meet all the above criteria for sample evaluation.

STAGE 2: PRICE AND PREFERENCE POINT

The 80/20 preference point system, which applies to bids with a Rand value equal to or above R2000 and up to a Rand value of R50 million (all applicable taxes included), shall be applied, where a maximum of 80 points will be allocated for price and maximum of 20 for a specific goal in terms of the requirements of the Preferential Procurement Policy Framework Act (Act 5 of 2000), Preferential Procurement Regulations, 2022 and the Gauteng Department of Health Preferential Procurement Policy of 2022.

7.1 Highly Recommended Briefing Session

Before the proposal submission closing date, the bidders must attend a highly recommended briefing session to address and clarify any misunderstanding or ambiguity. If a bidder does not attend the highly recommended briefing session, the bidder shall not be regarded as non-responsive and will be not be disqualified. All enquiries beyond the closing date of the bid will not be considered.

7.2 Copyright

This document may be reproduced and distributed under the strict condition that the content hereof is not altered unless the alteration has been done by authorised personnel stipulated by the GDOH and the standard GDOH document control procedures are followed.



7.3 Incorrect Information

Where a contract has been awarded on the strength of the information furnished by the Bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Gauteng Department of Health may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred by the Gauteng Department of Health as a result of the award of the contract.

7.4 Breach of Contract

Should either party commit or breach the provisions of this contract or fail to remedy any breach/es within 14 days after the receipt of a written complaint, the party that is not in default shall be entitled to cancel this contract per written notice delivered to the other party's domicillum citandi et executandi as per bid document without prejudice to any other right which the non-defaulting party may have as a result of such breach.

7.5 Transfer and Cession

The preferred bidder/contractor shall render the supply of body bags themselves, and the use of subcontractors will not be allowed without prior written permission.

7.6 Use of fluid-correcting substances

Using any corrective fluid/tape is strictly prohibited and will result in the disqualification of the Bidder from the evaluation process.

7.7 The GDOH shall:

- a) Not accept responsibility for any damages suffered by the Service Provider or their personnel for the duration of the contract.
- b) Not accept any responsibility for accounts/expenses incurred by the Service Provider that was not agreed upon by the contracting parties.
- c) Shall not provide a storage facility for transportation, equipment and materials.

7.8 Content

This document references various standards and specifications applicable to the relevant business sector within the Republic of South Africa. Changes to these standards and specifications effected during preparing this document have not been considered and may



vary. Changes or queries detected in this document must be brought to the attention of the GDOH.

Compliance with the item specifications does not confer immunity from legal obligations.

7.9 Payment Terms

Section 38(1)(f) of the PFMA and Treasury Regulation 8.2.3 regulates the payment to suppliers within 30 days of invoice receipt. In support of this, the successful bidder/s on the award must register for GPT Electronic Invoice Submission and Tracking.

7.10 Lines of Communication and Reporting

The appointed Service Provider will be required to report to the designated GDOH official at the Facilities Unit, who will be introduced to the successful Service Provider on appointment.

7.11 Late Bids

Bids received after the closing date and time at the address indicated in the bid documents will not be accepted for consideration and, where applicable, be returned unopened to the Bidder.

8. THE CONDITIONS OF THE BID AWARD

- a. The Gauteng Department of Health reserves the right to award or not award the tender.
- b. Each item will be awarded to the Bidder whose bid scored the highest combined price and preference points out of 100.
- c. The Gauteng Department of Health reserves the right to accept part of the tender rather than the whole tender.
- d. Bidders are required to register with National Treasury Central Supplier Database.
- e. The Gauteng Department of Health reserves the right to do due diligence evaluation of the selected bidder/s.
- f. The successful Bidder must be tax compliant at the awarding of the bid.
- g. The Gauteng Department of Health reserves the right to make a multiple bid award of the same items for continuity of supply to maintain stock levels. The Department will use its discretion to determine the multiple awards.

8.1 Travel

The Gauteng Department of Health will not be liable for any other travel costs incurred by the Bidder.



8.2 Counter conditions

Bidders' attention is drawn to the fact that amendments to any of the Bid Conditions or setting of counter conditions by bidders may invalidate such bids.

8.3 Fronting

- a. The Gauteng Department of Health supports the spirit of Broad-based Black Economic Empowerment. It recognises that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and an honest, fair, equitable, transparent and legally compliant manner. Against this background, the National Treasury condemns any form of fronting.
- b. The Gauteng Department of Health, in ensuring that bidders honestly conduct themselves, will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in bid documents.
- c. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry, be established during such enquiry/investigation, the onus will be on the bidder/contractor to prove that fronting does not exist.

8.4 AUTHORISATION DECLARATION

- 8.4.1 Any bidder sourcing goods or services from a third party must complete the "Authorization Declaration" in full for all relevant goods or services, sign it and submit it with the bid documents at the closing date and time of the bid.
- 8.4.2 The Gauteng Department of Health reserves the right to verify any information supplied by the Bidder in the Authorization Declaration, and should the information be found to be false or incorrect, the Gauteng Department of Health will exercise any of the remedies available to it in the bid documents.
- 8.4.3The Bidder must ensure that all financial and supply arrangements for goods or services have been mutually agreed upon between the Bidder and the third party. No agreement between the Bidder and the third party will be binding on the Gauteng Department of Health.
- 8.4.4 The bidders must submit a duly completed and signed Authorization Declaration, with the required annexure(s), in accordance with the above provisions to not delay the evaluation of the bid.



8.5 Contract period

The contract shall be for three years.

8.6 Validity Period

The validity period of the bid will be 90 days from the closing date of the advert.

- 8.7 Mergers, takeovers and changes in supplier detail.
 - a. Where a contracted supplier merges with or is taken over by another, the contracted supplier must inform the Department of Health in writing immediately (within 7 days) of relevant details.
 - b. The Department of Health reserves the right to agree to the transfer of contractual obligations to the new supplier under the prevailing contract conditions or to cancel the contract.
 - c. A contracted supplier must inform the Department of Health within 7 days of any address, name or banking details changes.

8.8 Third parties

- a. Participating authorities will not make a payment to or consult regarding orders with a third party.
- b. No third party is entitled to put an account on hold.

8.9 Cost

The Gauteng Department of Health will not be held responsible for any costs incurred by the service provider in preparing and submitting the Bid and Samples.

8.10 Guarantee

The contractor shall fully guarantee all items against manufacturing defects due to factory defaults. Contractors must refund or replace the failed, unsafe and defective goods without charges.

8.11 Samples

8.11.1 The successful bidder/s must submit samples upon request at the Bidder's costs.



- 8.11.2 Bidders will be allowed fourteen (14) days after requested in writing for samples for evaluation purposes. The Bidder must submit one sample for the requested item labelled with the Bidder name and item number. Samples will not be accepted without labelling.
- 8.11.3 Testing of samples to verify compliance with specifications.
 - a. Random samples will be drawn from each delivery to verify compliance with the specification in terms of the following:
 - The thickness of the plastic is not less than 150 microns.
 - Visual inspection of workmanship, inclusive of heat-bonding, attachment of zips, zip type and colour, quality and functionality.
 - Visual inspection of workmanship of the screen-printed wording on the body bag, including print colour, font type, size, line spacing, and adhesiveness of the paint to the body bag.
 - b. Body bags found to be defective or that become defective during storage due to poor workmanship, e.g. paint peeling off or deterioration of the plastic, shall be collected by the service provider at the service provider's expense. The defective body bags will be inspected in the presence of the service provider to verify defects. Defective body bags must be replaced within the lead time with body bags that meet the specifications and quality requirements.

8.12 Deliveries

The Gauteng Department of Health will not be responsible for any damages to any item in transit and during delivery.

8.12.1 Delivery Period

- a. The bidders must comply with the stated 7 days delivery period.
- b. Successful bidders must adhere strictly to the agreed delivery periods regarding items awarded to them under the signed contract and the special conditions and requirements of the contract.
- c. Should the successful Bidder fail to adhere strictly to the agreed delivery periods, the Gauteng Department of Health reserves the right, without notice, to purchase similar supplies from another supplier.
- d. The right is also reserved for purchasing requirements elsewhere outside the contract should:

Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider contract termination according to GCC Clause 23.

8.12.2 Delivery Quantity

- a. Quantities reflected in the bid forms are estimated quantities, and no guarantee is given or implied as to the actual quantity that will be procured during the contract period.
- b. The ordered quantities may not be exceeded. Any over-supply will not be accepted and returned to the supplier at his own expense.

8.12.3 Deliveries Areas

- 12.2 The cost of transport, delivery, labour or other additional costs must be included in the bid price.
- 12.3 Prices submitted for this bid must be filled in on the field provided on the price schedules supplied.
- 12.4 Price structures that do not comply with this requirement may invalidate the bid.



13. PURCHASE ORDERS

- 13.1 Contractors should note that Forensic Medical Service Head Office generate annual purchase orders and is responsible for the payment(s) thereof.
- 13.2 Contractors should note that the order(s) will be placed as and when required during the contract period, and delivery points will be specified by the relevant purchasing institution(s). The letter of acceptance constitutes a binding contract. Please note that no deliveries should be made unless an official and authorised order form has been received from the Gauteng Department of Health Central Office.
- 13.3 The instructions on the official order form regarding the supply, dispatch and submission of invoices must be strictly followed. Under no circumstances should the contractor deviate from the orders issued by the purchasing institutions.

- 1.1 Rules of interpretation. In this Agreement:-
 - 1.1.1 clause headings are for convenience and are not to be used in its interpretation;
 - 1.1.2 unless the context indicates a contrary intention an expression which denotes:-
 - 1.1.2.1 any gender shall include the other genders;

 - 1.1.2.4 references to clauses, schedules, parts and sections are, unless otherwise provided, references to clauses, schedules, parts and sections of this Agreement.
- 1.2 Meanings of expressions and words. In this Agreement the following expressions and words have the meanings assigned to them below and derivative expressions and words will have a corresponding meaning: -
 - 1.2.1 Agreement means this agreement read together with the General and Special Conditions of Contract of Contract RT3-2009R which form an integral part of this Agreement

- 3.2.7 to supply the quantities of spare parts, toner, developer, fuser oil and other consumables necessary to keep the equipment in proper operating condition;
- 3.2.8 to make available of full coverage maintenance, including preventive maintenance, all service calls and replacement all defectives or worn parts including expandable parts, and all consumable supplies. Should the Supplier fail to provide any of the consumables, or repair or replace with an equivalent unit, any equipment as required, then the Rental Copy Charges for the relevant month in respect of such equipment shall be forfeited by the Supplier and accordingly the Enduser shall not be required to pay such rental and copy charges. - 3.6.3 The Supplier shall be responsible for all the acts, defaults and negligence of its subcontractors and their experts, agents or employees as if they were acts, defaults or negligence of the Supplier shall not be absolved from its responsibility from under this clause on the basis that such person was acting outside the scope of its engagement by The Supplier.
- 3.6.4 The Supplier will provide the End user with a list (regularly updated for the duration of this agreement) of all the subcontractors that it intends using to perform all or any of its functions in terms of this agreement.

3.7 **CONFIDENTIALITY**

3.7.1 The Supplier shall treat all documents and information received in connection with this agreement as private and confidential, and shall not, save in so far as may be necessary for the purposes of performance thereof, publish or disclose any particulars without the prior written consent of the End user.

4. OBLIGATIONS OF THE END - USER

- 4.1 The End user undertakes to:
 - 4.1.1 Use the equipment for the purpose that it is intended and in accordance with any reasonable manufacturers' instructions and user manual as to the use thereof;
 - 4.1.2 Keep the equipment in its possession and custody and control at its premises in accordance with the same policies and procedures that the End user applies in respect of its own assets and equipment;
 - 4.1.3 Advise the supplier prior to relocation equipment.
 - 4.1.4 Allow the supplier or its representatives reasonable access to the inspection of the equipment on prior written notice;
 - 4.1.5 Undertakes to ensure that the installation area, access ways, electrical supply and where relevant, the IT configuration of its premises and other equipment or any network are suitable for the installation, passage and electrical/or electronic connection of the equipment when it is delivered for installation and thereafter.

5. BREACH

- 5.1 Either party commits a breach of contract where it fails to discharge any of its obligations in terms of this agreement;
- 5.2 Should either party commit a material breach of this agreement ("the defaulting party") and fail to remedy such breach within ten (10) days of written demand from the other party ("the aggrieved party") then the aggrieved party may, in addition to any other rights and remedies that it may have, including the right to claim damages:-
- 5.2.1 Claim specific performance;

- 5.2.2 or Terminate this agreement, such termination to be effective immediately upon receipt by the defaulting party of written notice to that effect
- 5.3 In any case where the End User is entitled to damages, then the End -user may claim such damages from the Supplier;
- This agreement shall automatically and without notice terminate upon occurrence of the following events:
 - 5.4.1 a receiver, liquidator or administrator is appointed over any of the property or assets of that the Supplier;
 - 5.4.2 the Supplier makes any voluntary arrangement with its creditors by reason of financial difficulty or becomes subject to an administration order, or provisional or final liquidation or insolvency order;
 - 5.4.3 the Supplier goes into liquidation or is declared insolvent; or
 - 5.4.4 that the Supplier ceases, or threatens to cease, to carry on business.

6. PAYMENT

The End – User shall pay the Supplier:

- 6.1 the rental applicable to the contract at the time of signing this agreement which rental shall be fixed for the entire initial rental period of 36 months. In the event of the extension of the contract, the rental shall reduce by 75% of the original rental The first Rental Charge shall be paid after the Commencement Date of the Agreement, within 30 days of the date of the original copy of statement or tax invoice to the Enduser and shall thereafter be payable monthly in arrear within 30 days of the last day of the month in which The Supplier delivers an original copy of statement and tax invoice to the End-user.
- 6.2 Copy Charges, applicable on the contract at the time of signing this Agreement will apply and would thereafter be adjusted on the thirteenth month and twenty-fifth month of the contract period.
- 6.3 The first of the Copy Charges shall be paid within thirty (30) days in which the original copy of statement and tax invoice in respect thereof is rendered, and shall thereafter be payable monthly in arrears on the first day of the month following the month in respect whereof the Copy Charge has arisen or within 30 days of the last day of the month in which the original copy of statement and tax invoice is delivered to the End-user, whichever is the later.
- 6.4 Payment shall be paid by electronic means into bank account :

- Whole Agreement. This Agreement constitutes the entire Agreement between the Parties in respect of the subject matter hereof and neither Party shall be bound by any undertakings, representations, warranties or promises not recorded in this Agreement.
- 8.2 **No Variation.** This agreement together with General Conditions of Contract, Special Conditions of the contract and all Standard Bidding Documents constitutes the entire agreement between the parties. No variation or consensual cancellation of this Agreement and no addition to this Agreement shall be of any force or effect unless reduced to writing and signed by the Parties or their duly authorised representatives.
- 8.3 **Waiver.** No waiver of any of the terms and conditions of this Agreement will be binding or effectual for any purpose unless expressed in writing and signed by the Party hereto giving the same, and any such waiver will be

effective only in the specific instance and for the purpose given. No failure or delay on the part of either Party hereto in exercising any right, power or privilege hereunder will operate as a waiver thereof, nor will any single or partial exercise of any right, power or privilege preclude any other or further exercise thereof or the exercise of any other right, power or privilege.

- 8.4 **Severability.** Should any of the terms and conditions of this Agreement be held to be invalid, unlawful or unenforceable, such terms and conditions will be severable from the remaining terms and conditions which will continue to be valid and enforceable. If any term or condition held to be invalid is capable of amendment to render it valid, the Parties agree to negotiate an amendment to remove the invalidity.
- 8.5 Applicable Law. This Agreement will be governed by and construed in accordance with the law of the Republic of South Africa and all disputes, actions and other matters relating thereto will be determined in accordance with such law.

GENERAL CONDITIONS OF CONTRACT July 2010

NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if (applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

- 1. The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.

1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

2. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za

4. Standards

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
- 5. Use of contract documents and information; inspection.
- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. Performance

7.1 Within thirty (30) days of receipt of the notification of contract award,

security

- the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

8. Inspections, tests and analyses

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the

cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2 Documents to be submitted by the supplier are specified in SCC.

11. Insurance

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental services

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
 - (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties,

- provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

- 14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
 - (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
 - (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

- 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser

may have against the supplier under the contract.

16. Payment

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated in SCC.

17. Prices

17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

18. Contract amendments

18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

19. Assignment

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily

available.

- 21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.
- 21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
 - (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - (b) if the Supplier fails to perform any other obligation(s) under the contract; or
 - (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the

envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

- 23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
 - (i) the name and address of the supplier and / or person restricted by the purchaser;
 - (ii) the date of commencement of the restriction
 - (iii) the period of restriction; and
 - (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
- 24. Anti-dumping and countervailing duties and rights
- 24.1 When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a
 provisional payment or anti-dumping or countervailing right is
 increased in respect of any dumped or subsidized import, the State is
 not liable for any amount so required or imposed, or for the amount of
 any such increase. When, after the said date, such a provisional
 payment is no longer required or any such anti-dumping or
 countervailing right is abolished, or where the amount of such
 provisional payment or any such right is reduced, any such favourable
 difference shall on demand be paid forthwith by the contractor to the
 State or the State may deduct such amounts from moneys (if any)
 which may otherwise be due to the contractor in regard to supplies or
 services which he delivered or rendered, or is to deliver or render in
 terms of the contract or any other contract or any other amount which
 may be due to him

25. Force Majeure

GT/GDH/057/2023

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
 - (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies due the supplier.

28. Limitation of liability

- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
 - (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

- (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
- 29. Governing language
- 29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
- 30. Applicable law
- 30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
- 31. Notices
- 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties

- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
- 33. National 33.1 Industrial Participation (NIP) Programme
 - The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.

34. Prohibition of Restrictive practices

- 34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).
- 34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
