The Nkomazi Local Municipality invites interested parties who are registered as CIDB grade 7CE or higher for replacement of AC pipes and the refurbishment of water treatment works (WTW) in Komatipoort. A preferential system shall apply whereby this contract will be allocated to a bidder in accordance with the Preferential Procurement Policy Framework Act, no 5 of 2000 and as defined in the bid document, read in conjunction with the Preferential Procurement Regulation, 2022 where 90 points will be allocated in respect of price and 10 points in respect of targeted goals.
