A compulsory briefing session will be held at **09:H00 on Thursday, 10 November 2022** at the **Municipal Depo, Corner of Dassieweg in Rollnick Street Oudtshoorn**. No grace period will be allowed.

The municipality reserves the right to withdraw any invitation to tender and / or re-advertise or to reject any formal quotation or to accept a part of it. The Municipality does not bind itself to accept the lowest formal quotation or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this formal quotation may not materialize.

Formal quotations will be evaluated in terms of the **80/20** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (2017) and the Municipality’s Supply Chain Management Policy. Note, it is prerequisite that all prospective service providers who are not yet registered on the Central Supplier Database to be registered, registration can be done online via www.csd.gov.za

Further that Local Content and Production will form part of the evaluation and therefore all potential bidders who fail to meet the minimum threshold for local content will not be considered for award.
