The Department of Economic Development forms part of the City's Economic growth Cluster, the vision is to grow an economy that is inclusive, liveable and prosperous for all. The primary role of the Department is to facilitate and coordinate economic development and transformation to stimulate growth in the City by collaborating with other City Departments and Municipal Entities, different spheres of government and the private sector. The mandate of the Department is to proactively intervene in the City's economy to create an environment for accelerated local economic growth that is sustainable and ensures that the benefits and opportunities are equitably shared by all citizens.

The City's GDS 2040 specifies Economic Growth and Development as a strategic pillar in delivering the vision of enabling, resilient and inclusive economy for all who live in it. The success of the Department of Economic Development's communications activities, publicity and proactive public relations initiatives lies in managing key and critical relationships with all business-related stakeholders, be it media, communities, investors, consumers, organised labour and internal stakeholders. It is important that communication is relevant, coherent and succinct.

It is within this context that the Department develop/compile publications to communicate the technical context to various stakeholders.
