PART 1

Conditions of Bid

1. BACKGROUND AND INTRODUCTORY PROVISIONS

1.1 Refer to **Part 2** of this invitation to bid for background and introductory information relating to the Services and this invitation to bid.

2. OFFER AND SPECIAL CONDITIONS

- 2.1 Without detracting from the generality of clause below, bidders must submit a completed and signed and requisite bid forms attached as Part 3 with its bid.
- 2.2 <u>All bids submitted in reply to this invitation to bid should incorporate all the forms, parts, certificates</u> and other documentation forming part of this invitation to bid, duly completed where required.
- 2.3 It is a requirement that an original valid Tax Clearance Certificate be submitted with the bid.
- 2.4 In the event that any form or certificate provided in Part 3 of this invitation to bid does not have adequate space for the bidder to provide the requested details, the bidder should attach an annexure to such form or certificate on which the requested details should be provided and the bidder should refer to such annexure in the form or certificate provided.

3. CLOSING TIME OF BIDS AND PROVISIONS RELATING TO SUBMISSION OF BIDS

- 3.1 The closing date and time for the receipt of bids in response to this invitation to bid is detailed on the cover page of this invitation to bid.
- 3.2 All bids must be submitted in a sealed envelope bearing the bid number, bid description and closing date.
- 3.3 All bids must be deposited before the closing time and date stipulated above in the bid box at the address detailed on the cover page of this invitation to bid.

4. ENQUIRIES

4.1. Should any bidder have any enquiries relating to this invitation to bid, such enquiries may only be addressed to the person/s detailed on the cover page to this invitation to bid in writing.

5. COMPULSORY BID BRIEFING/SESSION

5.1. There will be **NO** briefing session for this tender.

6. TAX CLEARANCE

6.1. The bidder should submit an original valid tax clearance certificate together with the bid documentation. A pro forma application for Tax Clearance Certificate (SBD 2) is attached as **Part 3 – Schedule B**. Bidder

must take specific note of the conditions stipulated in SBD 2.Tax clearance certificate and B-BBEE certificate must be renewed every 12 months and must be submitted to Supply Chain Management.

7. PRICING

- 7.1 The bidder(s) must submit details regarding the bid price for the Services on the Pricing Schedule form/s attached as Part 3 Schedule C which completed form/s must be submitted together with the bid documents.
- 7.2 Pricing of all lines must be stipulated **INCLUSIVE OF VALUE ADDED TAX.**
- 7.3 Price list should be submitted on the official company letter on a PDF document and a soft copy(on the original excel format.
- 7.4 Final price of all the items quoted should be transferred Part A (invitation to bid)-Page 1.
- 7.5 Prices submitted should be inclusive of all cost (including delivery cost) to all the Agency's offices across the nine (9) provinces.
- 7.6 It is an express requirement of this invitation to bid that the bidders provide some transparency in respect to their pricing approach. In this regard, bidders must indicate the basis on which they have calculated their pricing by completing all aspects of the Pricing Schedule form Part 3 Schedule C

8. <u>DECLARATION OF INTEREST</u>

8.1. The bidder should submit a duly signed declaration of interest (SBD 4) together with the bid. The declaration of interest is attached as <u>Part 3 – Schedule D.</u>

9. DECLARATION OF BIDDER'S PAST SUPPLY CHAIN MANAGEMENT PRACTICES

9.1. The bidder must complete the declaration and sign accordingly to submit with the bid. The declaration of bidder's past supply chain management practices is attached as

10. QUALIFICATIONS OF BIDDERS

10.1. Bidders must submit detailed information together with their bid and disclose the experience in the relevant trade together with present contracts. These details should be submitted together with the bid on the form attached as <u>Part 3 – Schedule G</u>

11. PARTNERSHIPS AND LEGAL ENTITIES

11.1 In the case of the bidder being a partnership, close corporation or a company all certificates reflecting the names, identity numbers and address of the partners, members or directors (as the case may be) must be submitted with the bid.

12. CONSORTIUM / JOINT VENTURE

12.1 It is recognized that bidders may wish to form consortia to provide the Services.

- 12.2 A bid in response to this invitation to bid by a consortium shall comply with the following requirements:-
- 12.2.1 It shall be signed so as to be legally binding on all consortium members;
- 12.2.2 One of the members shall be nominated by the others as authorized to be the lead member and this authorization shall be included in the agreement entered into between the consortium members;
- 12.2.3 The lead member shall be the only authorized party to make legal statements, communicate with the SSA and receive instructions for and on behalf of any and all the members of the consortium;
- 12.2.4 A copy of the agreement entered into by the consortium members shall be submitted with the bid.
- 12.2.5 Each party to the Consortium must submit a BBBEE Status Level Verification certificate.
- 12.2.6 Each party to the Consortium must submit an original and valid Tax Clearance Certificate.
- 12.2.7 Preference points will be only awarded when a consolidated BBBEE Certificate is submitted.

13. ORGANISATIONAL PRINCIPLES

13.1. The bidder should submit a clear indication of the envisaged authorized organizational principles, procedures and functions for an effective delivery of the required Service. These details should be submitted on the form attached as Part 3 – Schedule H

14. <u>DETAILS OF THE PROSPECTIVE BIDDERS NEAREST OFFICE TO THE LOCATION OF THE CONTRACT</u>

14.1 The bidder should provide full details regarding the bidders nearest office base in the province (see Part 3 of this invitation to bid). These details should be provided on the form attached as Part 3 - Schedule J, which completed form, must be submitted together with the bid.

15. FINANCIAL PARTICULARS

15.1. Bidder must provide full details regarding its financial particulars and standing, which particulars should be submitted together with the bid on the form attached as <u>Part 3- Schedule K</u>.

16. PREFERENCE POINTS CLAIM FORMS

16.1. Part 3 – Schedule L contains the Preference Points Claim Forms in terms of Preferential Procurement Regulations, 2021 to be completed and signed by the bidder to the extent applicable and returned with this bid.

17. VALIDITY

17.1. Bid documentation submitted by the bidder will be valid and open for acceptance for a period of (150) calendar days from the closing date and time stipulated on the front cover of this invitation to bid.

18. ACCEPTANCE OF BIDS

- 18.1 The SSA does not bind itself to accept either the lowest or any other bid and reserves the right to accept the bid which it deems to be in the best interest of the Agency.
- 18.2 The SSA reserves the right to award the bid in wholly or in part thereof.
- 18.3 The SSA reserves the right to appoint more than one bidder .

19. NO RIGHTS OR CLAIMS

- 19.1 Receipt of the invitation to bid does not confer any right on any party in respect of the Services or in respect of or against the SSA. The SSA reserves the right, in its sole discretion, to withdraw by notice to bidders any Services or combination of Services from the bid process, to terminate any party's participation in the bid process or to accept or reject any response to this invitation to bid on notice to the bidders without liability to any party. Accordingly, parties have no rights, expressed or implied, with respect to any of the Services as a result of their participation in the bid process.
- 19.2 The SSA, nor any of their respective directors, officers, employees, agents, representatives or advisors will assume any obligations for any costs or expenses incurred by any party in or associated with any appraisal and/or investigation relating to this invitation to bid or the subsequent submission of a bid in response to this invitation to bid in respect of the Services or any other costs, expenses or liabilities of whatsoever nature and howsoever incurred by bidders in connection with or arising out of the bid process.

20. NON DISCLOSURE, CONFIDENTIALITY AND SECURITY

- 20.1 The invitation to bid and its contents are made available on condition that they are used in connection with the bid process set out in the invitation to bid and for no other purpose. All information pertaining to this invitation to bid and its contents shall be regarded as restricted and divulged on a "need to know" basis with the approval of the SSA.
- 20.2 In the event that the bidder is appointed pursuant to this invitation to bid such bidder may be subject to security clearance prior to commencement of the Services.

21. ACCURACY OF INFORMATION

- 21.1 The information contained in the invitation to bid has been prepared in good faith. The SSA nor any of their respective directors, advisors, officers, employees, agents, representatives make any representation or warranty or give any undertaking express or implied, or accept any responsibility or liability whatsoever, as to the contents, accuracy or completeness of the information contained in the invitation to bid, or any other written or oral information made available in connection with the bid and nothing contained herein is, or shall be relied upon as a promise or representation, whether as to the past or the future.
- 21.2 This invitation to bid may not contain all the information that may be required to evaluate a possible submission of a response to this invitation to bid. The bidder should conduct its own independent analysis of the operations to the extent required to enable it to respond to this bid.

22. COMPETITION

- 22.1 Bidders and their respective officers, employees and agents are prohibited from engaging in any collusive action with respect to the bidding process which serves to limit competition amongst bidders.
- In general, the attention of bidders is drawn to Section 4(1) (iii) of the Competition Act 1998 (Act No. 89 of 1998) (the Competition Act) that prohibits collusive bidding.
- 22.3 If bidders have reason to believe that competition issues may arise from any submission of a response to this bid invitation they are encouraged to discuss their position with the competition authorities before submitting response.
- Any correspondence or process of any kind between bidders and the competition authorities must be documented in the responses to this invitation to bid.

23. RESERVATION OF RIGHTS

- 23.1 Without limitation to any other rights of the SSA (whether otherwise reserved in this invitation to bid or under law), the SSA expressly reserves the right to:-
- 23.1.1 Request clarification on any aspect of a response to this invitation to bid received from the bidder, such requests and the responses to be in writing;
- 23.1.2 Amend the bidding process, including the timetables, closing date and any other date at its sole discretion;
- 23.1.3 Reject all responses submitted by bidders and to embark on a new bid process.

24. CONDITIONS AND MINIMUM REQUIREMENTS

- 24.1 Upon formal approval of the Contract and prior to the commencement of the Contract, the successful bidder(s) shall be required to sign a General Conditions of Contract and a Service Level Agreement, including the Special Conditions of Contract.
- 24.2 This Contract shall be non-exclusive and SSA reserves the right to, including during the term of this Contract, to enter into any agreement or arrangement with any other entities or persons for the performance of all or any part of these services. SSA shall incur liability to the appointed Service Provider by virtue of its entry into such agreements or arrangements.
- 24.3 In accordance with Treasury Instruction Note dated 31 May 2011, this Specific Term Contract shall be excluded from the value limits as orders shall be placed as and when the services are required and that on the time of awarding the Contract, exact required quantities shall not be known. SSA shall therefore not guarantee to the successful bidder(s) any monetary value or minimum quantity of any services to be provided under Contract and SSA shall not be under any obligation to order a minimum quantity of services from the successful bidder(s) under the Contract. SSA shall further not be obligated to make use of every service that is tendered for. Any quantities and/or volumes requested in the pricing schedule are for comparative bid purposes only. The delivered price shall be for the actual quantity and/or volume.
- 24.4 All staff directly involved will be required to sign an "Oath of Secrecy" and be bound to the Protection of Information Act, 1982 (Act 84 of 1982).

25. SECURITY REQUIREMENTS

- 25.1 **Security clearances:** The bidder's (principal or joint venture contractor) employees and sub-Bidders *are* required at all times during the contract period to be in possession of valid security clearances to the level determined by SSA commensurate with the nature of the project activities they are involved in. The cost of obtaining suitable clearances is for the account of the bidders.
- The vendors shall supply and maintain a list of personnel involved on the account indicating their clearance status. Negative or failure of security clearance or vetting by the bidder/bidder's employees or partners at any stage during the contracting or contract period and lack of or inability to obtain acceptable replacements by the contractor may lead to the cancellation of the contract. The Bidders and their sub-Bidders will be revetted for every event during the period of contracting (3 years).

PART 2

Terms of reference

SUPPLY AND DELIVERY OF STATIONERY FOR A PERIOD OF <u>THREE (3) YEARS</u> INCLUDING DELIVERIES TO ALL NINE PROVINCIAL OFFICES

1. PURPOSE

- 1.1 The State Security Agency (SSA) is looking for the appointment of a Service provider for the supply of Stationery for a period of (3) three year as per the attached stationery lists. The list in not exhaustive and additional items may be added as and when required by the Agency.
- 1.2 The service providers who wish to submit bid must have been on continuous and non-interrupted stationery business for a minimum of 3 years (must be supported a CIPC registration).

2. BACKGROUND

2.1 The State Security Agency is a National Government Department Agency with Provincial Offices situated throughout the country with the Head Office based in Pretoria. There is a need for stationery in order to maintain daily running of the day to day activities. The Agency requires qualified supplier(s) to supply the agency across all the provinces.

3. SCOPE OF THE PROJECT

- 3.1 The successful bidder will be expected to supply and deliver stationery for a period of (3) three years to the State Security Agency as per the specification attached.
- 3.2 The supply of items shall be made to SSA Head Office and all the Provincial Offices within seven (7) working days after the receipt of official Purchase Order.

4. SPECIFICATIONS

- 4.1 Please refer to the stationery list attached.
- 4.2 The list in not exhaustive and additional items may be added as and when required by the Agency. The process of adding items on the contract will be as follows:
 - SCM will request a quote from the appointed service provider
 - Two additional quotes will be requested from service providers on the CSD
 - The quote of the service provider will be compared with the two additional quotes and negotiations conducted with the appointed service provider to get a market related price.
- 4.2 Bidders are expected to submit prices on all items as per the attached list of items. Prices should be in the quantity of one, for comparative purpose. Failure to bid on any one of the items will deem the bid as nonresponsive.
