Bids will be evaluated on the 80/20 principle and according to the risk matrix as per CIBD Practise Note 5.

Tenders must be compliant with all bid requirements stated in the tender document.

Tenderers must bind the document in a manner so that it does not fall apart. Bidders are specifically referred to the requirements of the Preferential Procurement Regulations, 2022, including but not limited to pre-qualification criteria, functionality, eligibility, statutory, local content, compulsory sub-contracting, other objective, and price and preference criteria as stated in the tender document. If applicable, only locally produced, or manufactured goods meeting the stipulated minimum threshold for local production and content, will be considered. Tenderers' attention is drawn to the registration requirements in the tender documents in respect of registration on the municipal supplier database, Central Suppliers' Database, Construction Industry Development Board (if applicable), etc.

Local content:

- Steel products with a stipulated minimum threshold of 100% and HDPE pipes of 100 % plastic - local production and content will be considered.
- The exchange rate to be used for the calculation of local production and content must be the exchange rate published by the South African Reserve Bank (SARB) at 12:00 on the date of advertisement of the bid; and
- Only the South African Bureau of Standards (SABS) approved technical specification number SATS 1286: 2017 must be used to calculate local content.
