- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

#### 2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## **ARC-OVR INFECTEOUS WASTE SPECIFICATIONS: 36 MONTHS CONTRACT**

The required services, on a 36-months, contract is limited to the delivery of SANS 452 approved containers; collection and disposal of OVR-BTP-TAD laboratory-generated infectious waste.

## **Definitions**:

For the purposes of this specification and contract,

♣ infectious waste shall be defined and limited to:

"Waste which contains infectious agents (microorganisms including bacteria, mycobacterium, fungi, parasites, or viruses which normally causes, or significantly contributes to infectious diseases and result in an increased morbidity or mortality of humans or animals) in sufficient concentrations or quantities to cause disease in humans, animals and/or may lead to environmental contamination"

- ♣ 'SANS 452' means the South African National Standard for Non-reusable and Reusable Sharps Containers.
- ♣ SANS 10248-1' means the South African National Standard for the Management of Health care Waste, Part 1: Management of Health Care Risk Waste from a Health Care Facility

## **Scope of Work**

- Supply/delivery of SANS 452 and SANS 10248-1 approved waste containers,
- Once-a-month collection and disposal of all full SANS 452 approved waste containers,
- ♣ After disposal and prior payment, submit proof of destruction certificate (waste certificate) from a treating facility/disposal site that is fully compliant/accredited with the National Regulations on Health Care Risk Waste (NEMWA, act 59 of 2008),
- ↓ Vehicles used to transport ARC-OVR infectious Waste must comply with the National Road Traffic Act, 1996 (Act 93 of 1996), South African National Standards 10231, 10232, 10228 and 10229, as well as any standard set by the City of Tshwane Metropolitan Municipality's by-laws of a municipality in whose area of jurisdiction it operates

Types of infectious waste to be collected and disposed under this contract shall be limited to the below-listed categories. *This excludes all animal carcasses, their body parts and any human or animals related pathological waste*:

• <u>Sharps</u> include needles, glass tubes, scalpels, blades, slides or any "sharp" item that is used to inoculate, provide drugs, to draw blood, used during testing or derived from an animal or human

- <u>Laboratory waste</u> can include cultures, blood/serum, stocks, agents, biological and chemical residues that are created or used by laboratories in the development of treatments or analysis of disease processes that can be infectious to humans upon exposure.
- <u>Personnel Protective Clothing (Hand Protective Clothing/Items)</u> contaminated with blood/plasma/serum or any other laboratory sample. This includes gauze, gloves and dressing material containing small amounts of animal blood or other animal body secretions.
