The 80/20-preference point system will be used for the evaluation of the contract. The Swartland Municipality endorses and supports the Government's Black Economic Empowerment Programme and is committed to rectify the inequalities of the past. For bidders to qualify for the advantages of the B-BBEE Act, they must thoroughly complete the attached Annexure MBD 6.1. **There will be no benefits if the schedule is not thoroughly completed. Preference points MUST also be claimed in paragraph 6.1.** Bidders are required to submit **original and valid B-BBEE Status Level Verification Certificates or certified copies** thereof together with their bids, to substantiate their B-BBEE rating claims. Bidders are also required to submit **Proof of Locality** in order to claim points for locality.

Duly completed tenders in a sealed envelope marked "**TENDER T51.23.24 – Appointment of Professional Land Surveyors**" together with the name and address of the Tenderer must be deposited in the tender box at the **Municipal Head Offices, on the cnr of Kerk and Voortrekker Street before 12:00 on Friday 7 June 2024** upon which the tenders will be made public.
