1. BACKGROUND AND INTRODUCTION

Amatola Water (AW) is a state-owned water utility established in November 1997 and is mandated to render water services to water sector institutions, local government and other customers in the Eastern Cape.

This programme is aimed at mitigating the current water shortages through the provision of water supply to different communities on short-term bases, while long-term solutions are considered. The short-term solution will be implemented through provision of rainwater harvesting tanks.

2. SCOPE OF WORKS

The Department of Water and Sanitation instructed the Amatola Water (AW) as their Implementing Agent (IA) for the Supply, Delivery, and Installation of 600 Rainwater Harvesting Tanks to 6 Great Places within the Eastern Cape Province. 100 tanks are to be provided to each of the six Great Places as follows.

- Ngadu Great Place in Amathole District Municipality
- Rharhabe Great Place in Amathole District Municipality
- Bumbane Great Place in OR Tambo District Municipality
- Qamata Great (Western Tembuland) in Chris Hani District Municipality
- Qaukeni Great Place in OR Tambo District Municipality
- Kroza Great Place in OR Tambo District Municipality

2.1 SPECIFICATION REQUIREMENTS

The work to be carried out by the supplier under this contract comprises mainly the following:

- Supply and deliver (traveling km to transport the tank from the supplier/manufacture to be included in this rate) to site (Great Place) 5000 Litre Rainwater Harvesting Tank made up of polyethylene material. The tank to be SABS approved and have minimum of 10 year guarantee.
- Supply and deliver to site Rainwater Harvesting Tank Stand (stand to be made on the similar material as the tank, and the minimum stand height to be 400mm)
- Supply and deliver to site of Plastic Tap and the fittings

- Supply hand stampers
- Supply and deliver to site building cement bags
- Supply and deliver to site Gutter Brackets
- Supply and deliver to site Gutter Stop Ends
- Supply and deliver to site Gutter Union Clips
- Supply and deliver to site Gutter Outlets
- Supply and deliver to site Gutter offset bends
- Supply and deliver to site Gutter 12m lengths
- Supply and deliver to site down pipes (3m)
- Supply and deliver to site Fascia boards white @ 12m
