TERMS OF REFERENCE FOR THE APPOINTMENT OF AN ACTUARIAL CONSULTANT TO CONDUCT ACTUARIAL VALUATIONS OF POST-RETIREMENT MEDICAL AID BENEFIT OBLIGATIONS FOR A PERIOD OF THREE YEARS

1. Purpose

The South African Diamond and Precious Metals Regulator (SADPMR) seeks to appoint a suitably qualified and experienced actuarial consulting firm to conduct actuarial valuations of the post-retirement medical aid benefit obligation for a contract period of three (3) years. The valuation must comply with the requirements of Generally Recognised Accounting Practice (GRAP) 25.

2. Background

SADPMR contributes 66.5% of the post-retirement medical aid premiums for qualifying retired employees. GRAP 25 requires entities to measure and disclose post-employment benefit obligations based on an appropriate actuarial valuation method. The cost of a defined benefit plan is subject to long-term uncertainties associated with salary progression, medical inflation, mortality assumptions, employee behaviour, and other demographic factors.

To ensure compliance and accurate long-term financial reporting, SADPMR requires periodic actuarial valuations and projections of its post-retirement medical aid liability.

3. Scope of Work

The appointed service provider will be required to carry out the following:

3.1 Actuarial Valuation

- Conduct a comprehensive actuarial valuation of SADPMR's post-retirement medical aid benefit obligation in accordance with GRAP 25.
- Apply appropriate actuarial assumptions, including but not limited to discount rates, medical inflation, mortality rates, withdrawal rates, retirement ages, and other demographic and economic assumptions.
- Provide sensitivity analyses demonstrating how changes in key assumptions affect the liability.
- Provide all other relevant information, analyses, disclosures and supporting schedules necessary for a complete, compliant, and comprehensive actuarial valuation report.

3.2 Projections and Reporting

- Provide a three-year projection of post-retirement medical aid liabilities and related expenses.
- Provide comprehensive actuarial valuation reports annually for the duration of the contract.
