The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the provision of Consulting Engineering Services for the Improvement on National Route R49 Section 2 from Km 90.00 to Km 101.40, Kopfontein Border Post. This project is in the province of North West and in the local municipality of Ramotshere Moiloa and the approximate programme is for design and construction documentation to be completed by **April 2026**, followed by supervision of **24** months (including 3-month mobilisation period), commencing **November 2026**.

Only tenderers who are registered on the National Treasury Central Supplier Database and meet the minimum requirements for the key persons as stipulated in Clause C.2.1 at the tender closing date, are eligible to tender.

Joint Ventures (JV) will be allowed on condition that one JV partner is a Targeted Enterprise. The JV partner will, however, not contribute to sub-contract target for Targeted Enterprises.
