1.1 DESCRIPTION OF SERVICE: PROCUREMENT OF 6 × VARIABLE VOLUME AIR DISPLACEMENT SINGLE-CHANNEL PIPETTES (2 × 1000 µL, 2 × 200 µL AND 2 × 100 µL)

BACKGROUND:

Variable volume air displacement single channel pipettes are essential in the laboratory for daily use for accurate measurement of small volumes required to achieve various project objectives. The aforementioned pipettes will replace outdated pipettes that has been in use since 1996. The maintenance will include yearly servicing and calibration. The expected savings are due to protection against breakages of equipment due to load-shedding and power failures.

PURPOSE

The requested equipment is needed to deliver the required research output and generation of external revenue.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the

purchaser.
