

## REQUEST FOR SUPPLY AND DELIVERY OF ELECTRICAL HV ARC SUIT AND VOLTAGE DETECTOR NON-CONTACT.

### 1. PURPOSE:

The purpose of this service request is to invite quotations for supply and delivery of HV arc suit and HV voltage detector non-contact.

### 2. BACKGROUND:

It is an OHS Act 85 of 1993 and ORHVS (Operating Regulations of High Voltage Systems) requirement to put on relevant PPE (Arc suit when operating HT apparatus) and personnel also require a non-contact HV tester to verify or confirm if the power is switched off before working.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has

suffered as a result of having to make less favourable arrangements due to such cancellation;

- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution, if deemed necessary.
