- Basic and Applied Nuclear Physics Research using Particle Beams
- Research Radiation Biophysics
- The supply of Accelerator-produced Radioactive Isotopes for Nuclear Medicine and Research

CONTEXT OF THIS PROCUREMENT NEED

The glove box is required to support the safe synthesis and handling of astatine-211 (^{211}At), a short-lived alpha-emitting radionuclide used in targeted cancer therapy. Due to its radiological hazards, a glove box is essential to provide a controlled, shielded environment that ensures operator safety and product integrity.

The glove box will serve as the primary containment for the ^{211}At radiopharmaceutical synthesis module, meeting regulatory, radiation safety, and GMP requirements. It is a critical infrastructure for the production of ^{211}At .

PART A – CONTRACT

DETAILED SPECIFICATIONS

Requirement for Glovebox to serve as primary containment of an Astatine-211 (^{211}At) Synthesis Model

1. Purpose

This section outlines the requirements for a glovebox designed to serve as primary containment for a GMP-compliant ^{211}At Synthesis Module. The glovebox must meet the mandatory requirements and technical specifications (as stated in the section below) to ensure safe and efficient operation of a GMP-compliant ^{211}At Synthesis Module.

Quantity: Two (2)

Mandatory Requirements:

All the requirements listed under sections 2 to 6 are mandatory. The bidder must indicate whether their proposed glovebox complies with the requirements under sections 2 and 3 and whether the bidder complies and agrees with the requirements listed under sections 3 to 6 (installation, documentation; training; servicing; support and qualifications).

2. Glove box requirements

- 2.1 The glovebox must fulfil the requirements of the CE certification of a GMP-compliant ^{211}At Synthesis Module
- 2.2 The glovebox must provide a ventilated work compartment to contain vapor and/or particles containing ^{211}At and other radionuclides for operator protection.

- 2.3 The compartment size that will host the synthesis module of the glovebox must meet the minimum dimensions of 1200 mm x 660 mm x 850 mm (length x width x height).

- 2.4 The main glovebox compartment must support the weight of the synthesis unit of 40 kg and additional equipment (e.g. dose calibrator (25kg)).

- 2.5.1 1 x Power cable pass-through (Provision for synthesis unit, Power input for EU).

2.5.2 1 x Gas line pass-through for Nitrogen (The glovebox must have a regulated Nitrogen source connected to 1/8" OD FEP tubing routed to the inside of the work compartment). (It must be ready to be connected to the Synthesis unit inlet upon installation. The connector for 1/8" fluorinated Ethylene Propylene (FEP) tubing to Synthesis unit will be provided. The 1/8" OD FEP tubing length inside the work compartment must be of approximately 1m length to allow for rotation of the module during Installation Qualification (IQ) and Operation Qualification (OQ).

2.5.3 1 x Data cable pass-through for ethernet data connection cables between the laptop and Synthesis Unit. The control laptop and synthesis unit must be routed directly between said equipment, and not rely on routers, switches, adapters, converters, active nor passive. Data connection cables will be supplied.

2.6 The surface of the glovebox chambers must be replaceable, non-flammable work floor material (e.g., tray) in case of physical damage or chemically induced corrosion of the workflow material over time.

2.7 The glovebox must be equipped with at least three (3) gloves with a center pitch of 35-45 cm.

2.7.1 The gloves must be placed with the center of the gloves 30-35 cm above the surface on which the synthesis module is standing.

2.7.2 Gloves must be resistant to chloroform and other chemicals, with a melting point greater than 105°C.

2.7.3 The material of the gloves must be: Butyl rubber.

2.8 The synthesis unit must be placed in a compartment so that there is at least 20 cm of space between any side/front/back panel of the synthesis unit and the closest wall. There must also be at least 30 cm of space between the top of the furnace and the ceiling of the installation compartment. Note: Dimensions of synthesis unit (W x D x H): 605 mm x 435 mm x 535 mm

2.9 The glovebox compartment must have the facility to open a front door or remove a front panel or other panel to the synthesis unit with minimal dimensions (width x height) 650 mm x 550 mm to allow for synthesis unit installation.

2.10 The front door/panel must maintain an open state when opened, allowing for synthesis module manipulation (e.g., installation of consumables before each run). For a vertical front door opening mechanism, the design must ensure that the door's opening angle and edges are crafted to prevent the risk of operator head injury when the door is open.

2.11 The glovebox must have a material pass-through compartment to its main work chamber. Dimensions of the pass-through area must be approximately 25 cm width x 25 cm height x 45 cm length/depth. Door openings must be at least 20 cm x 20 cm. The material pass-through must allow for the insertion and removal of elements before process start, during process execution, and after process completion. The material pass-through must be capable to carry weight of shielding container with a weight of 30 kg. Sliding doors must be used between material pass-through and work compartment to minimize work-space. The material pass-through compartment must have a have a dedicated ventilation for radiation safety regulations.

2.12 An air exchange solution for the work compartment must be proposed and supplied by the bidder and must be verified for suitability by radiation safety division at iThemba LABS. The work compartment must be connected to an air exchange system which facilitates a minimum ≥ 20 air changes per hour inside the compartment (e.g., IAEA-TECDOC-1430).

2.13 A venting solution for the work compartment exhaust line must be-proposed and supplied by the bidder and must be verified for suitability by radiation safety division at iThemba LABS to avoid overheating of the work compartment. The compartment exhaust line must be connected to an exhaust system (HVAC) or an alternative solution complying to local radiation safety standards.

2.14 An intake and exhaust air filtration against radioactive material must be proposed and supplied by the bidder and must be verified for suitability by radiation safety division at iThemba LABS. For operator protection, it is required to protect intake and exhaust air by carbon filters to avoid contaminated air leakage, also in case of air exchange failure. For product protection (e.g. drug manufacturing), it is required to implement HEPA filters on air intake and exhaust lines.

2.15 Both air intake and exhaust for the glovebox must be equipped with manual shut-off valves to provide a means of validation for chamber pressure integrity testing (e.g., EN 12469) as well as isolation in case of emergency.

2.16 The work compartment main chamber differential pressure and means of control thereof must be proposed and supplied by the bidder and must be verified for suitability by radiation safety division at iThemba LABS according to local radiation safety standards. The work compartment pressure must be constantly kept below the surrounding laboratory environment pressure at -40 Pa to prevent radioactive release. The compartment must be equipped with a differential pressure gauge to constantly assess and visualize that the differential pressure criteria are maintained. The pressure gauges must be equipped with an alarm in case the differential pressure is less than its specified value relative to the surrounding laboratory environment.

2.17 The glovebox compartments must be equipped with a radiation dose monitoring system within the compartment.

2.19 Provision must be made for the installation of a dose calibrator (ionization chamber) inside the work area compartment to enable measurement of samples during ^{211}At processing without the need for sample extraction from the work compartment.

2.20 The space consumption of the dose calibrator must be compatible with the specific synthesis unit hardware space and distance requirements inside the compartment.

2.21 There must be space to position the synthesis control laptop outside the work compartment but in proximity to the work compartment such as a laptop holder tray attached to the outside of the work compartment. The laptop installation space must be larger than the synthesis control laptop dimensions: (W x D x H) 375 mm x 30 mm x 273 mm. The laptop position must be such that it allows for the simultaneous interaction of the synthesis unit through gloves and observation of the synthesis control laptop screen.

3.1 The glovebox must comply with all radiation safety standards and certifications required for the operation of the

GMP-compliant 211At Synthesis Module Synthesis model.

MANDATORY QUALIFICATION TO EXECUTE THE CONTRACT

- 1. The bidder provides the following as proof of being able to execute the contract to the contract terms:**
 - 1.1. Provide at least one (1) contactable reference where the bidder has supplied a GMP compliant glove box suitable for containment of an Astatine-211 Atley C100 or similar Synthesis unit.
 - 1.2. Bidders are required to complete the specifications in the bid document ("Yes or No"). If any response is NO then an alternative to meet the requirement must be stipulated by the bidder. Failure to completely respond to the bid document specifications may disqualify the bidder.
 - 1.3. Presentation of the proposed systems elements from the bidders is required if bidder meets the requirements under section 2 to 6 on page 2 to page 8.

Implementation, hand over, and product management

The appointed bidder provides the delivery management as specified in the detailed specification / terms of reference. iThemba LABS will issue purchase orders as a project control tool "for each batch/lot being despatched and will monitor the execution of the delivery schedule until the purchase order requirements are received on site.

Incidental Services to the subject matter of this contract (General Condition of Contract Clause No: 13)

In the event of requiring such incidental services, it is only valid if confirmed through the issue of a written purchase order that specifies, where applicable, quality, quantity, description, unit price, and delivery date.

Performance Verification (General Condition of Contract Clause No: 8)

The iThemba LABS appointed project manager verifies the performance of this contract with reference to the required requirements and any other element specified in this contract:

1. The appointed bidder will render services as per specifications under this contract.
2. Both parties agree on quantity, unit cost, and total value on the same signed document.

Contract Due Diligence during the contract period

iThemba LABS has the right to conduct supply chain due diligence. The iThemba LABS Project Team have the right to conduct site visits and inspections at any given time during the contract period.

Communication (General Condition of Contract Clause No: 31)

The appointed bidder communicates in writing through regular mail, physical delivery, or email. The appointed bidder states the contract number and purchase order number on communication documentation. The contract bidder does not act upon any communication without the contract number or must verify such communication with the iThemba LABS project manager prior to acting upon it.

Performance Security (General Condition of Contract Clause No: 7)

An acceptable financial performance bond is required where iThemba LABS pays an upfront deposit in excess of R 1 million to the same value as any such upfront deposit. No other performance security is required.

Packing (General Condition of Contract Clause No: 9)

Components (where applicable) must be packaged such that they prevent damage during transportation and storage.

Payment (General Condition of Contract Clause No: 16)

Payment terms are within 30 days of receipt of an invoice issued following successful rendering of services and earlier where the invoices are accompanied by signed iThemba LABS delivery validation documents including proof of performance stating acceptance of quantity, acceptance to specification, and unit pricing in agreement with the contract and any purchase orders issued in terms of the contract.

It is in the interests of the appointed bidder to adhere to these to receive prompt payment. Any losses incurred through exchange rate variations or interest charged on late payment will be charged to the appointed bidder where these costs arose from non-adherence to the above.

Prices (General Condition of Contract Clause No: 17)

The price schedule for the bid under the contract shall not vary from the prices quoted by the service provider in their bid with iThemba LABS with the exception of any price adjustments authorized in this section.
