Bidders are therefore required to submit the certified copy of the BBBEE certificate, original BBBEE certificate or the sworn affidavit.
- 2.4. Completed and signed Standard Bidding Documents (SBD) forms included in the bid document.
3. The above specified goods/services should be delivered / rendered to the ARC-Onderstepoort Veterinary Institute at above-mentioned delivery address.
4. The particulars of the guarantee that will apply to the goods quoted for, with the particular regards to the period and extent of the warranty must be clearly stated. Where services are required, service providers must submit documentation pertaining the relevant experience.
5. Your written quotation must be deposited or emailed depending on the instructions given in the email.
6. All price quotations that have a rand value of R 30,000.00 to below R 50,000,000.00, including VAT, will be evaluated by applying the 80/20 principle as prescribed by the Preferential Procurement Policy Framework Act 5 of 2000 and its Regulations. The lowest acceptable price will score 80 points, the 20 BBBEE points will be allocated as follows:

7. Standard conditions:

7.1 The validity of the quotations must be indicated.

7.4 The supplier accepts full responsibility for the proper execution and fulfilment of the goods/services quoted for.

7.6 Quotes should be submitted on an official letterhead and duly signed.

7.7 Goods and services should be supplied / rendered upon receipt of a purchase order from the ARC.

7.8 The General Conditions of Contract issued by National Treasury are applicable.

7.9 The ARC supply chain management code of conduct is applicable.

7.10 Standard Bidding Documents (SBD) forms must be signed and returned together with the quotation if the price is above R 10,000.00. Failure to comply will result to disqualification of your quotation.
