### **3 INTRODUCTION AND BACKGROUND**

Freedom Park is a dedicated precinct celebrating South Africa's heritage, a center of knowledge aimed at creating a deeper understanding of the country and its people.

Compromising many diverse elements, Freedom Park strive to accommodate all of the country's unfolding experiences and symbols to tell one coherent story of the struggle of humanity for freedom in South Africa – the struggle for survival, land and resources and how they shaped the social, economic, political, cultural and historical landscape of the country; it address gaps, distortions and biases to provide new perspectives on South Africa's heritage, challenging traditional narratives through a re-interpretation of the country's existing heritage site

### **7.1 SPECIFICATIONS**

7.1.1 The required service provider will be required to carry out the maintenance and the parking surrounding areas. The successful service provider will be required to carry out the following duties of the park for a period of three years:

- Cleaning of the Park and preventing veld fires;
- Maintain veld grass, flowers and hand blowing of leaves in the parking area and road;
- Planting trees if necessary;
- Cleaning of pavement;
- Removal of weeds and alien plants;
- Maintaining of the water features;
- Maintaining of the irrigation system including spares;
- Maintaining of the wooden deck, wooden benches and wooden poles. i.e. by applying oil as required by specification; and
- Maintenance of the nursery.

## **8 INDUCTION AND PLACEMENT OF STAFF**

- 8.1 The Service Provider's staff members will have to undergo induction training regarding the site and the Emergency Plan for the Campus.
- 8.2 This induction is compulsory and must be attended by the service provider's employees to work on site.
- 8.3 Any new employee must first be inducted before placement on this site.
- 8.4 The inheritance of existing labour from previous Service Providers must be discussed with and approved by Freedom Park beforehand.

## **9 OPERATION MANAGEMENT EXCELLENCE**

- 9.1 All shifts are 8 hours and start at 07:30 for 16:00.

## **10 LANGUAGE PROFICIENCY**

- 10.1 All employee must be able to speak English and at least one other official language. Due to the nature of our business, communication is essential and it is therefore required that employees can communicate with client visiting the Park.

## **11 MINIMUM WAGE**

- 11.1 The prospective service provider must pay his/her employees the minimum monthly basic salary, as prescribed by the Basic Conditions of Employment Act, No 75 of 1997. The prospective service provider's pricing costs on this bid must not be below prescribed minimum wage.

## **12 PROVISION OF CONTINGENCY PLAN FOR LABOUR UNREST AND STRIKES ON SITE**

- 12.1 When the service is interrupted or temporarily deferred because of any labour unrest, labour disputes, civilian disorder, a local or national disaster or any other cause, the service provider must ensure the activation and implementation of contingency plans until full and normal service is restored.

**NB:** The prospective service provider is required to provide a convincing contingency plan to illustrate how it would ensure the services is provided to Freedom Park facilities in the event of/or any labour unrest and strikes by workers.

- 12.2 The prospective service provider must provide a detailed plan on how the *ad hoc* services will be arranged and implemented throughout the contract. The prospective service provider's *ad hoc* plan must provide details on the following aspects:**

- a) How would the prospective provider arrange for the required *ad hoc* services?
- b) How much time will the service provider need to arrange the required service?
- c) How will the prospective service provider cover the required sites?
- d) Provide the details on how resources will be made available for *ad hoc* services?
- e) Indicate how the *ad hoc* will be managed and who will manage such services?



### **13 MONTHLY INVOICING AND PAYMENT**

- 13.1 Monthly payments will be made in accordance with the general conditions of contract and the invoicing must be done in accordance with the following procedure:
- 13.2 Invoices shall be based on shift registers and certified time sheet by the Freedom Facility Unit. Certified shift registers and time sheet shall be processed for payment within thirty (30) days of receipt thereof after proper verification is completed.
- 13.3 Only original invoices accompanied by a monthly statement will be accepted for payment.

### **14 ANNUAL INCREMENT**

- 14.1 Annual increases (where applicable) for the required services shall be strictly calculated based on inflation rate.

### **15 SOCIAL RESPONSIBILITY**

- 15.1 The successful service provider is required to bring a minimum of 250 learners, from a school of their choice at a discounted rate of R40 per learner per annum during the duration of the contract.

### **16 CONFIDENTIALITIES**

- 16.1 Any or all information made available to the Service Provider by the Freedom Park shall be regarded as confidential and shall not be made available to third parties without the prior written consent of the Freedom Park.

### **10 SERVICE LEVEL AGREEMENT**

- 10.1 The successful Bidder will be expected to sign a SLA within 30 Days of their appointment.

## **17 RESPONSIBILITIES**

### **7.11.1 The Service Provider will provide and take responsibility for the following:**

- Staff working on site
- Personal Protective Equipment for staff on site
- Required consumables to execute the contract (fuel, oil etc.)
- Inspection register
- Comply with the Occupational Health and Safety Act and Regulations (Act 85 of 1993)
- The service provider shall ensure that each staff will at all times, when on duty, be fully dressed with (Personal Protective Equipment.
- A neat and clearly identifiable overalls which must be provided by the service provider. The uniform must include rain-coats for personnel performing labour duties in inclement weather.
- Handle all problems and challenges experienced by staff on sites.
- Attend to all problems regarding personnel wages, family and any other problems.
- Ensure that there is always operating equipment on site according to the contract.
- Ensure that staff on site are suitably trained to the required level and competent to render the landscaping and maintenance services.
- Liaise with Freedom Park representative and Facility Unit on site.
- Shortages and late coming by staff must be recorded in the register book and the Freedom Park' Facility unit shall reserve the right to keep to records on such incidents.
- The Service Provider is to supervise and give instructions to their staff on site and to ensure that the Service Level Agreement conditions are complied with.

### **7.11.3.1 The Freedom Park reserves the right:**

- a) To verify any information supplied in the tender documents;
- b) Not to appoint any Service Provider;
- c) Reject all bids;

- d) To cancel or withdraw this RFP at any time without attracting any penalties or liabilities;
- e) Request further information from any bidder after the closing date for clarity purposes;
- f) Decline to consider any bids that do not confirm to any aspect of the bidding requirements;
- g) To have the final say in the appointment and that this will be binding;
- h) To disqualify a tender or cancel any subsequent contracts should it be found that information disclosed was factually inaccurate and/or that a misrepresentation of facts may have occurred; and
- i) Inspection to shortlisted companies as part of evaluation.

## 8 PRICING INSTRUCTION

### 8.1 General

8.1.1 This section provides the tenderer with guidelines and requirements with regard to the completion of the Price Schedule. The Schedule has to be completed in black ink and the tenderer is referred to the Tender Specifications in regard to the correction of errors.

8.1.2 The Price Schedule shall be read with all the documents which form part of this Contract.

8.1.3 The following words shall have the meanings hereby assigned to them:

**Unit:** The unit of measurement for each item of work in terms of the Specifications and the Project Specifications.

**Quantity:** The number of units of work for each item.

**Rate:** The payment per unit of work at which the tenderer tenders to do the work.

**Price:** The product of the quantity and the rate tendered for an item.

**Lump sum:** An amount tendered for an item, the extent of which is described in the Price Schedule, the Specification and the Scope of Work, but the quantity of work of which is not measured in any units.

### 8.3 Rates

- 8.3.1 This price list has columns for quantity, rate and price for the goods. Entries in these columns are made as follows:
- 8.3.2 If the Supplier is to be paid an amount for the goods which is a fixed price for an item or a fixed price for each of a series of items, the tendering supplier enters the amount in the price column only, the other two columns being left blank.
- 8.3.3 If the Supplier is to be paid an amount for the goods which is the unit rate for each item multiplied by the quantity of the item supplied, (i.e. a 'Price Schedule' arrangement) - the tendering supplier enters the rate which is then multiplied by the quantity (which has been entered either by him or by the Purchaser) to produce the price which is also entered.
- 8.3.4 If the Supplier is to be paid an amount for an item of the goods which is the rate multiplied by the quantity supplied -whatever that quantity turns out to be (i.e. a 'schedule of rates' arrangement) - the tendering supplier enters the rate only, the other two columns being left blank. The tendering supplier's offer cannot include a total of the prices which covers all the items which the Supplier has to supply if any of the supply is dealt with using items with a rate only.
- 8.3.5 Rate only entries must not be made for work covered by other items.

## **CORRECTION OF ENTRIES MADE BY TENDERER**

*Any entry made by the Tenderer in the Price Schedule, forms, etc, which the tenderer desires to change, shall not be erased or painted out. A line shall be drawn through the incorrect entry and the correct entry shall be written above in black ink and the full signature of the Tenderer shall be placed next to the correction.*

## **9 EVALUATION CRITERIA**

The bid will be evaluated in 3 phases as follows:

1. Phase 1: Admin compliance
2. Phase 2: Functionality
3. Phase 3: 80/ 20-point system as prescribed in Preferential Procurement Policy Framework, Act of 2017.

### **9.1 Phase 1 Admin compliance**

- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 6.1, the contractor may be required to furnish documentary proof to the satisfaction of the purchaser that the claims are correct;
- iv) If the B-BBEE status level of contributor has been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the purchaser may, in addition to any other remedy it may have –
  - (a) disqualify the person from the bidding process;
  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution.

Delays in the supplier's performan</b>	<p>21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.</p> <p>21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.</p> <p>21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.</p> <p>21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.</p> <p>21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause</p> <p>21.2 without the application of penalties.</p>

	<p>21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.</p>
<b>22. Penalties</b>	<p>22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.</p>
<b>23. Termination for default</b>	<p>23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:</p> <p>(a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;</p> <p>(b) if the Supplier fails to perform any other obligation(s) under the contract; or</p> <p>(c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.</p> <p>23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.</p> <p>23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.</p> <p>23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.</p> <p>23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.</p> <p>23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:</p> <p>(i) the name and address of the supplier and / or person restricted by the purchaser;</p> <p>(ii) the date of commencement of the restriction (iii) the period of restriction; and</p> <p>(iv) the reasons for the restriction.</p>

	<p>These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.</p> <p>23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.</p>
<b>24. Anti-dumping and countervailing duties and rights</b>	<p>24.1 When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him</p>
<b>25. Force Majeure</b>	<p>25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.</p> <p>25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.</p>
<b>26. Termination for insolvency</b>	<p>26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.</p>
<b>27. Settlement of Disputes</b>	<p>27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.</p> <p>27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.</p> <p>27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.</p>

	<p>27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.</p> <p>27.5 Notwithstanding any reference to mediation and/or court proceedings herein,</p> <p>(a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and</p> <p>(b) the purchaser shall pay the supplier any monies due the supplier.</p>
<b>28. Limitation of liability</b>	<p>28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;</p> <p>(a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and</p> <p>(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.</p>
<b>29. Governing language</b>	<p>29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.</p>
<b>30. Applicable law</b>	<p>30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.</p>
<b>31. Notices</b>	<p>31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice</p> <p>31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice</p>
<b>32. Taxes and duties</b>	<p>32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.</p> <p>32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.</p> <p>32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.</p>
<b>33. National Industrial Participation (NIP) Programme</b>	<p>33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.</p>
<b>34 Prohibition of Restrictive practices</b>	<p>34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).</p>

	<p>34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.</p> <p>34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.</p>
