1. BACKGROUND

The National Lotteries Commission (NLC) is a public entity established by Lotteries Act No. 57 of 1997 as amended to regulate the South African Lotteries industry. The functions of the Commission can be divided into two categories, namely “regulation of National Lottery and other Lotteries” and “administration of the National Lottery Distribution Trust Fund (NLDTF)”.

Enterprise and Supplier development (ESD) entails the process of working collaboratively with suppliers to improve or expand their capabilities. ESD involves embracing suppliers and enterprises expertise and aligning its business needs towards empowerment. NLC seeks to appoint a service provider for the provision of office equipment for the National Lotteries Commission as outlined below in terms of the NLC SCM Policy and Treasury Regulations.

Early delivery of the required equipment is of paramount and appointed supplier may request partial delivery and payment can be done on goods delivered.

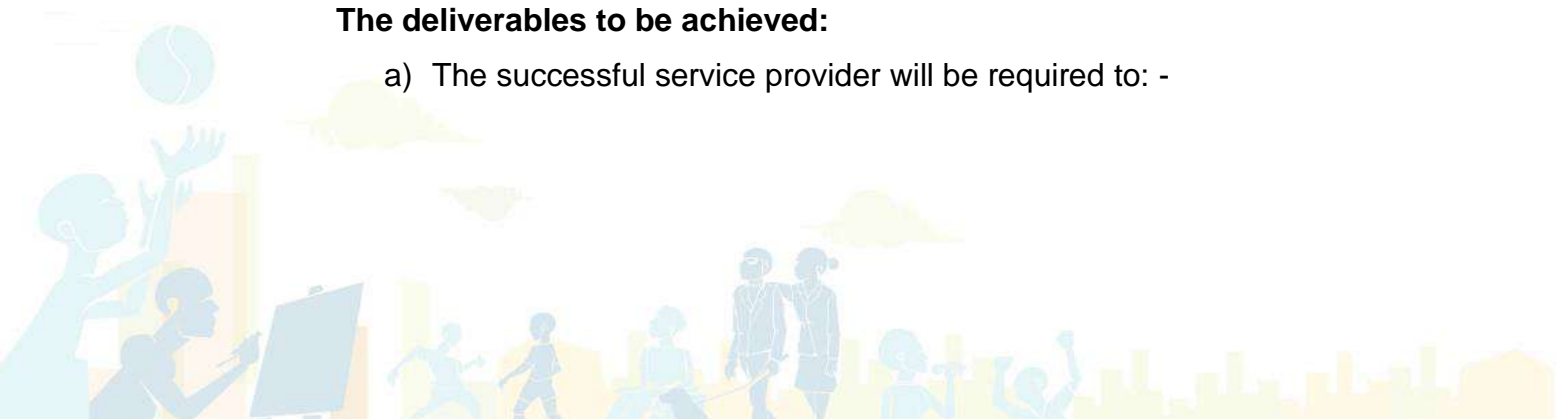
2. PURPOSE

5. **QUALITY CONTROL**

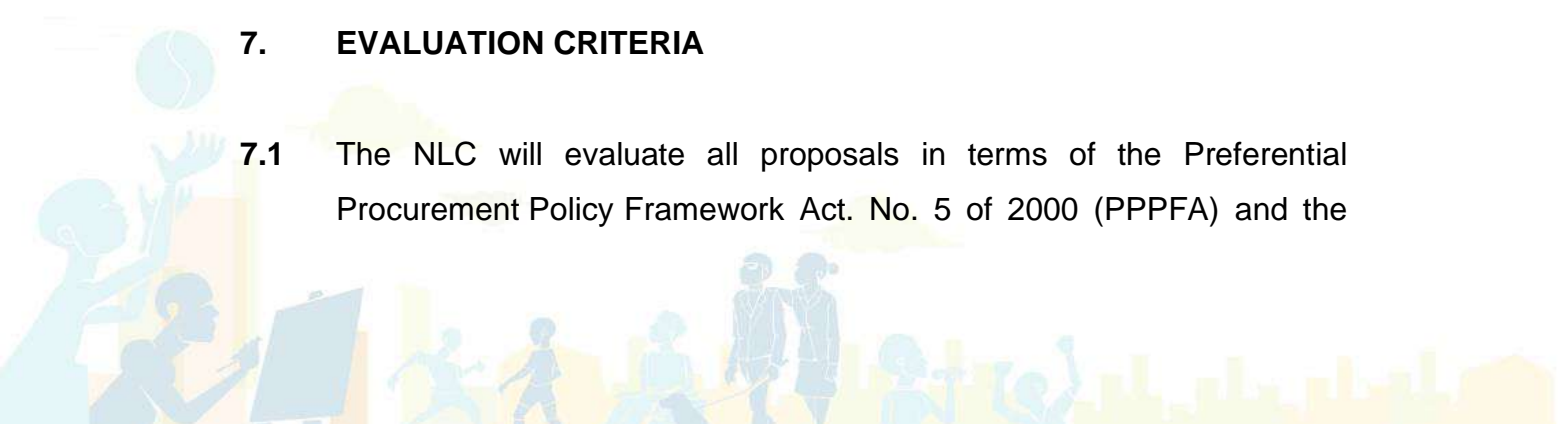
- The supplier must undertake and warrant that all goods shall, at the time of delivery, be according to specification, in good condition, order and ready for use.
- The supplier has the primary responsibility to ensure that **quantity and quality** are in accordance with the specification.

6. **PAYMENT**

- No payment will be made by the NLC before a service has been rendered.
- No payment will be made without an original invoice or certified copy.
- No payment will be processed before a full delivery is completed and accepted.
- Payment will be made within 30 days of receipt of the original or certified invoice from the supplier, provided that the NLC is satisfied with the quality and standard of the supplier's performance.

7. **EVALUATION CRITERIA**

- 7.1 The NLC will evaluate all proposals in terms of the Preferential Procurement Policy Framework Act. No. 5 of 2000 (PPPFA) and the

- 1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

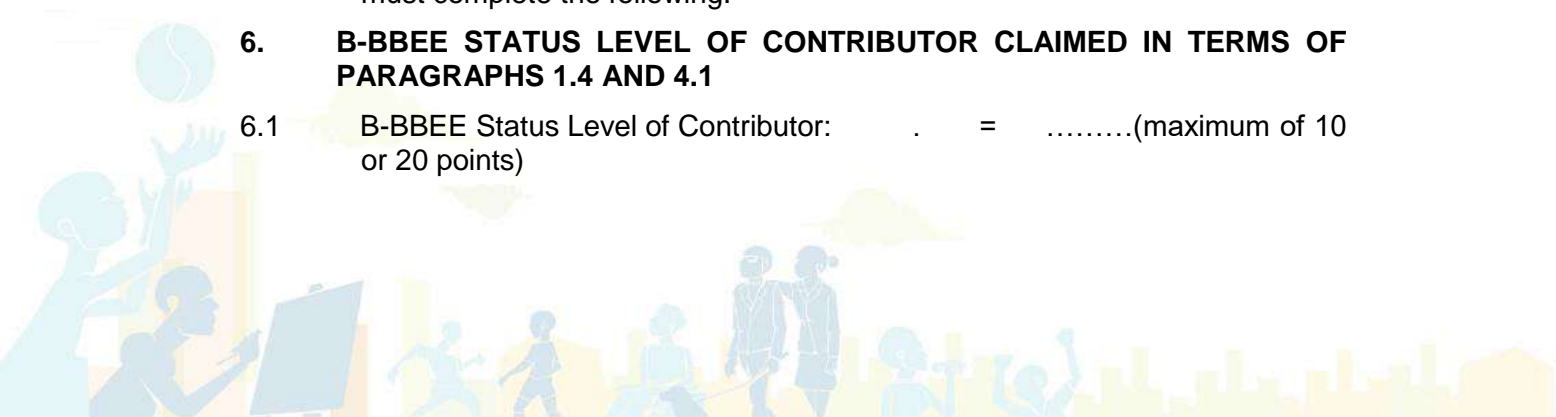

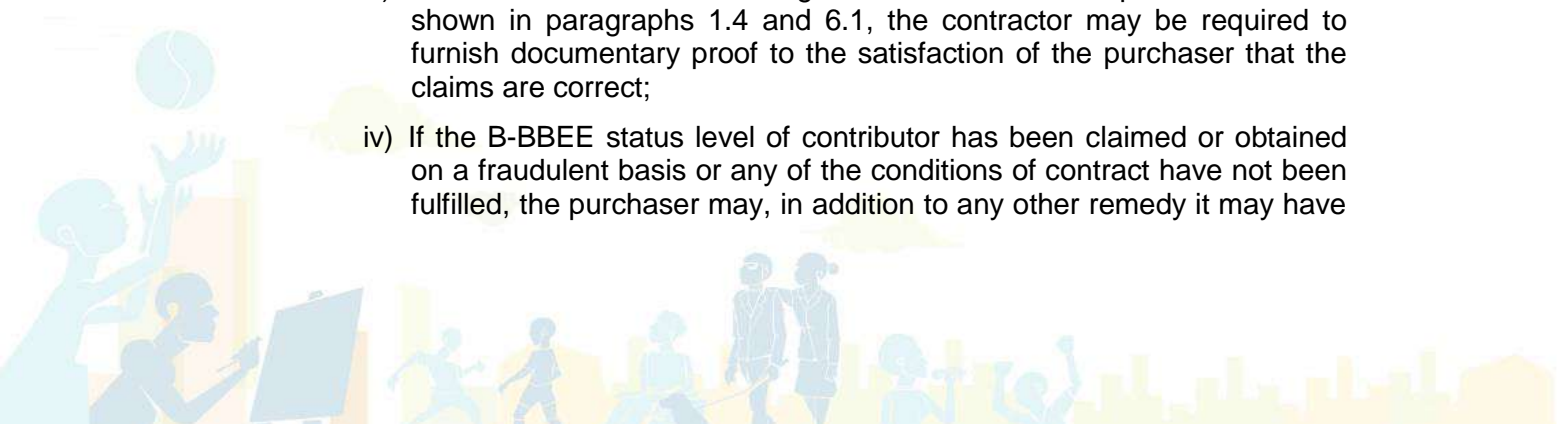

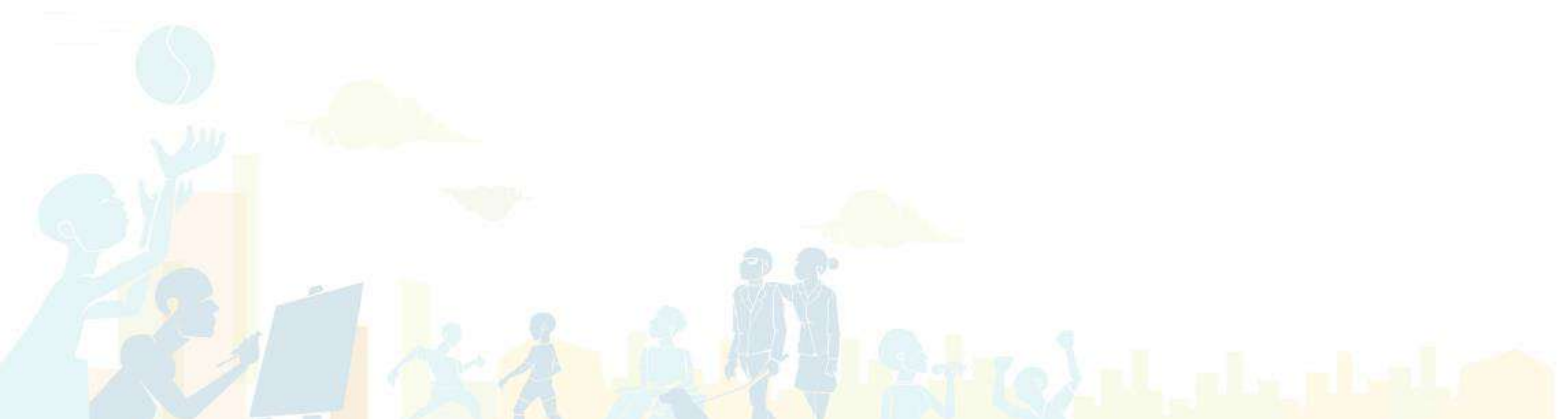
