**1. PURPOSE**

The purpose of this Request for Quotation (RFQ) is to appoint a suitably qualified service provider with a proven track record to handle all the event requirements of the City of Durban (eThekweni Municipality) for a concert that will be held at Moses Mabhida stadium on the 18<sup>th</sup> of June 2022.

**2. BACKGROUND**

The NAC, together with key strategic partners, will be hosting a benefit concert in support of the affected communities in the KZN province, as a result of the recent floods that left households being destroyed, living in shelters, injured, losing lives and missing.

**3. SCOPE OF WORK/SPECIFICATIONS**

The NAC is looking for an experienced Project Officer to perform the below duties:

- Obtain the necessary risk categorisation for the benefit concert,
- Ensure that the benefit concert has the appropriate public liability insurance
- Attend the City Joint Operations Committee meetings, and
- Ensure that proper compliance is observed.
- Secure the desired venue for the benefit concert
- Secure a Safety Officer

The service provider should demonstrate that they have the experience and skills to perform the above mentioned tasks

Preference will be given to an organisation or resident within the eThekweni Municipality, with a proven record and at least 5 years of experience working with the City on similar events.
