Dube TradePort Corporation (DTPC), a provincial public entity (Schedule 3C) in terms of the Public Finance Management Act) is a multi-modal development situated 30 kilometres north of the Durban city centre.

This is an invitation to prospective companies/individuals to submit proposals to DTPC for the purchasing of x-ray machines that DTPC intends to dispose. The x- ray machines have come out of a working environment and are in a working order. All assets have been defined in the call for proposal document.

The x-ray machines consists of:

- Smith Heimann 630 DI model (x2)
- Smith Heimann HISCANN145180 model (x4)

The successful company/individual will make their own arrangements with transport as well as labour to remove the x-ray machines from DTPC site.

EVALUATION OF THIS CALL FOR PROPOSAL

All proposals will be evaluated in various stages – compliance will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points will be allocated to the following as included in the call for proposal document:

- I. Enterprises (or bidders) who are at least 51% or more Owned by Black People (10 points).
- II. Enterprises (or bidders) who are at least 51% or more Owned by Women (5 points).
- III. Enterprises (or bidders) who are at least 51% or more Owned by Youth (5 points).
