
ROOF PLAN








NORTH ELEVATION





Location of the site in relation to the R45 to Franschoek, and the Skuifraam Dam





1000mm thick gabion wall internally reinforced and anchored to concrete footings: all to structural engineer's detail.






SKUIFRAAM 1 RUIN


