- The award of the tender may be subjected to price negotiations with the preferred tenderers.

#### COMPLIANCE WITH THE TENDER SPECIFICATION: -

- Fully completed by non-erasable ink and signed Bill of Quantities (obtainable from the Municipal Website and E-tender Website)
- Valid CIDB Grading
- Full CSD Report (Not older than one Month)
- CK/ Company Registration, Certified ID copies not older than six (06) months
- Tax compliance status PIN
- Fully Completed Tender Forms i.e. MBD 6.1 –. Return all returnable documents to the employer after completing them entirely by writing legibly in non erasable ink.
- In the case of partnerships/consortiums/ joint venture agreement, signed agreement must be submitted with the tender document, and
- All parties/partners to the partnership/ consortium/joint venture agreement must be registered on the Central Supplier Database

If Bidder submits Fraudulent Information the bidder will be blacklisted for five years.

NB: Failure to furnish all the above required documents, bidder will be disqualified.
