## SECTION A: QUESTIONS RECEIVED FROM THE TENDERERS

No.	QUESTION	ANSWER
Q1.	<p>Under clause C3.9 pertaining to key persons it states that “when a proposed candidate for any position is not in the permanent employ of the tenderer but a contracted person, this must be indicated on Form B2 and a signed letter of consent from the candidate must be submitted with the relevant B forms. When a proposed candidate for any position is a permanent staff member of the tenderer, this must be indicated on Form B2 and a signed letter of information must be submitted with the relevant B Forms”.</p> <p>This implies that a key person can be a permanent member or a contracted person. Alternatively, can this person be a permanent member of staff of the Targeted Enterprise? (this question pertains specifically to the Key Person Design Specialist (Structural Engineer)</p>	Clause C3.11 requires the Project Leader to be permanently employed by the tenderer. The Design Specialist (Structural Engineer) is not required to be permanently employed by the tenderer and can be supplied by the Targeted Enterprise, subject to the required information in Clause C3.11.
Q2.	Will the Alternate Key Persons also be scored/evaluated over and above the usual Key Persons?	The alternate key person will only be evaluated if the tendered key person is already committed to more than 6 current projects.
Q3.	Has any investigations or design been undertaken for streetlights as the design report doesn't contain anything?	The lighting component of the design has not yet commenced. Provision has been made for the tenderer to price for the electrical design from Concept stage onwards.
Q4.	Has the point of electrical supply been identified?	No investigation on the electrical supply has commenced.
Q5.	Does the client have specific types of lights and light poles that will have to be designed too?	SANRAL does not specify a specific light or pole.
