1. Mandatory requirements:

- 1.1 At least 1 contactable reference letter stating successful supply and delivery of any livestock not older than 6 years in South Africa
- 1.2 The supplier must provide a detailed minimum of 4weeks quarantine plan (with clear description of shelter, feed/fodder and healthcare plans)
- 1.3 A detailed transportation plan with images of vehicles to be used
- 1.4 Completion of Appendix B
(failure to submit the above will result in disqualification)

2. Animal health requirements (to be submitted by appointed bidder)

Chickens must be Free from HPAI, Newcastle, Salmonella and any other notifiable diseases

- Vaccination and disease-monitoring programme documentation required
- Detailed veterinary health certificate and movement permit to be provided
- Must be tagged
- To be dipped 1 week prior to delivery (certificates required)
- Transportation must avoid adverse weather (<5°C or >30°C, rain)

(failure to submit all the above on or before delivery of Goods may result in rejection of animals)

2. Essential Administrative Requirements:

2.1. Only bidders registered on the Central Supplier Database (CSD) will be considered. Bidders shall include full CSD report with the bid proposal.

2.2. Only bidders that claim specific goals will be considered for scoring on the 20 points as per the 80/20 principle.

2.3. Completed and signed Standard Bidding Documents (SBD) forms included in the bid document.

2.4. Valid copies of Tax pin Certificate and BBBEE to be submitted.

3. The above specified goods/services should be delivered / rendered to the ARC- Institute at above-mentioned delivery address.

- 1.1 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.2 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
