TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER TO UNDERTAKE PAPER RESTORATION ON ANTHROPOLOGICAL FILES KEPT BY THE DEPARTMENT

1. PURPOSE

The purpose of the Terms of Reference is to record mutual intentions and common understanding between CoGTA and the Service Provider which will govern how these parties will operate and commit to cooperation towards undertaking the paper restoration project, for the sole purpose it is intended.

2. BACKGROUND

The Department has, in its possession, volumes of anthropological files on the two hundred and eighty-nine (289) *ubuKhosi* found within the province of KwaZulu-Natal. In these files, there is information documented dating as far back as centuries ago, on the history, culture, customs, genealogies, and succession related matters of the various *ubuKhosi*.

These are rare and priceless documents, which anthropologists use and refer to daily when doing their work. They are used as reference for individual *ubuKhosi* and have in most cases assisted in resolving succession matters, especially disputes. Due to regular use and handling by anthropologists, they have over the years deteriorated in condition. While most of paper in the files is now torn on the edges, all the old ones have gone yellow due to their acidic nature, causing discoloration, and fading of the ink.

3. REQUIREMENTS

To undertake this exercise, the Service Provider is required to have a team that has the following qualifications and experience:

4. DELIVERABLES AND TIMING

The project will run for a period of three (3) months. The Service Provider will be expected to:

- Conduct technical analysis of all anthropological files.
- Isolate documents requiring restoration.
- Stabilize paper by applying the most effective treatment decisions.
- Provide detailed progress reports.
- Submit time sheets of hours worked.
- Conduct presentations on work completed.
- Render advice on the international best practice for handling and storing of documents containing information of cultural/historical/heritage significance.
- Submit a final report.

5. PROTOCOLS AND CONFIDENTIALITY

CoGTA acknowledges the confidentiality of information contained in the anthropological files. The Department therefore expects the Service Provider to undertake it in good faith and understanding that all the information contained in the files shall remain the property of CoGTA and therefore cannot be used anywhere else without the consent of either CoGTA or *imiNdeni yobuKhosi* concerned.
